A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO APPROVE THE ISSUANCE OF A BLANKET PURCHASE ORDER WITH AQUIFER MAINTENANCE & PERFORMANCE SYSTEM, INC. FOR ANNUAL WELL FIELD MAINTENANCE AND REPAIR SERVICES IN AN ESTIMATED ANNUAL AMOUNT OF \$100,000.00.

WHEREAS, the Department of Public Utilities requires annual well field maintenance and repair services; and

WHEREAS, the required services were competitively bid by the City of Sunrise, Florida; and

WHEREAS, the City of Sunrise solicitation number Bid 19-10-12-VH was awarded to the lowest responsive and responsible bidder, Aquifer Maintenance & Performance Systems Inc. ("AMPS"), for a three year initial term with two additional one year renewal periods; and

WHEREAS, AMPS has agreed to extend the same pricing, terms and conditions to the City of Hollywood as provided to the City of Sunrise; and

WHEREAS, the Interim Director of Public Utilities and the Director of Procurement & Contract Compliance recommend that the City Commission approve the issuance of a blanket purchase order for annual well field maintenance and repair services in an estimated annual amount of \$100,000.00; and

WHEREAS, Section 38.40 (C)(5) of the Purchasing Ordinance allows the Director to procure, without following formal procedures, all goods and services which are subject of contracts with the state, its political subdivisions, the United States government, other governmental entities, or a corporation not for profit whose members are governmental entities, public officers, or any combination thereof, provided that the goods and services are (i) the subject of a price schedule negotiated by the state or the United States government, or (ii) the subject of a contract with another governmental entity or a corporation not for profit whose members are governmental entities, public officers, or any combination thereof, which contract is based strictly on competitive bids or competitive proposals and not on any preference; and

WHEREAS, award is subject to the City's receipt and approval of all insurance certificates and endorsements required by the City's Risk Manager; and

WHEREAS, funding for the purchase has been appropriated and exists in account numbers: 442.409901.53600.552240.000743.000.000, 442.400501.53600.531170.000000.000.000, 442.400502.53600.546330.000000.000.000, and 442.400502.53600.531170.000000.000.000. NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA: That the foregoing "WHEREAS" clauses are ratified and confirmed Section 1: as being true and correct and are incorporated in this resolution. That it approves and authorizes the issuance, by the appropriate City officials, of a blanket purchase order with Aquifer Maintenance & Performance Systems Inc., together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.
