**Proposed Legislation:**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, RATIFYING THE SUBMISSION OF AN APPLICATION TO THE FLORIDA DEPARTMENT OF TRANSPORTATION TO RECEIVE A SUB-GRANT UNDER THE SAFETY OFFICE HIGHWAY SAFETY SUB-GRANT PROGRAM TO CREATE AN INITIATIVE TO REDUCE TRAFFIC ACCIDENTS INVOLVING FATALITIES AND INJURIES BY CONDUCTING DELIBERATE ENFORCEMENT OPERATIONS WHICH TARGET SPEED AND AGGRESSIVE DRIVING; AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ACCEPT, IF AWARDED, SAID SUB-GRANT IN AN APPROXIMATE AMOUNT OF \$40,000.00; AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE ANY AND ALL APPLICABLE GRANT DOCUMENTS AND AGREEMENTS; AND IF AWARDED, AMENDING THE FISCAL YEAR 2019 ADOPTED OPERATING BUDGET.
