## Explanation:

This Resolution seeks approval to issue a blanket purchase order with Enterprise FM Trust for the lease of 18 Code Compliance vehicles for each of the two seven month terms.

The total estimated cost for the lease of the vehicles is \$139,448.92; which is based on leasing 18 vehicles at \$505.66 per vehicle per month for 14 months (\$127,426.32), plus the additional cost of tinting, numbering and tags which is estimated at \$12.022.60.

Funding for the lease of 16 vehicles will be available in the FY 2019 Operating budget in account number 001.500401.53900.540050.000000.000.000, funding for one vehicle will be provided by the CRA and funding for one vehicle will be provided by the Sanitation Enterprise Fund. Funding to continue the lease will also be budgeted in the subsequent fiscal year.
