A RESOLUTION OF THE CITY COMMISSION OF THE CITY
OF HOLLYWOOD, FLORIDA, APPOINTING FIVE
MEMBERS TO THE GREEN TEAM ADVISORY
COMMITTEE.

WHEREAS, the City Commission passed and adopted Resolution No. R-2006-309, which created the Green Team Advisory Committee ("Committee"); and

WHEREAS, the City Commission passed and adopted Resolution No. R-2006-361, establishing the number of members and criteria for membership on the Committee; and

WHEREAS, the City Commission passed and adopted Resolution Nos. R-2013-090, R-2017-140, and R-2019-040, which restructured the Committee to eliminate certain positions, include new positions, and reduce the number of members on the Committee; and

WHEREAS, the current composition of the Committee consists of a total of 12 members from the following categories: two business representatives; one South Florida Builders Association representative; eight Citywide representatives, and one alternate member; and

WHEREAS, Paul Farren currently serves as a business representative and Sara Berke currently serves as a Citywide representative, and their terms expire on June 30, 2019; and

WHEREAS, Julia Johnson and Karen Rice-David both served as Citywide representatives, however both have resigned and their terms expire on June 30, 2021; and

WHEREAS, Renee Hicks served as a Citywide representative but due to her absenteeism, she was removed leaving the position vacant until June 30, 2021; and

WHEREAS, the City Clerk provided notice to the public that positions were available and solicited interest forms from citizens to fill the available vacancies; and

WHEREAS, the following individuals have expressed an interest in serving on the Green Team Advisory Committee and are qualified to fill the vacancies:
