A RESOLUTION OF THE CITY COMMISSION OF THE  
CITY OF HOLLYWOOD, FLORIDA, APPOINTING EIGHT  
MEMBERS TO THE EDUCATION ADVISORY  
COMMITTEE.

WHEREAS, on March 21, 2001, the City Commission passed and adopted Resolution R-2001-93 establishing the Education Advisory Committee ("Committee"); and

WHEREAS, R-2001-93 was subsequently amended by Resolutions R-2002-241, R-2003-144, R-2003-373, R-2004-203, R-2005-299, R-2007-421, R-2009-188, R-2011-143, R-2012-186, R-2013-088, R-2015-262 and R-2018-176, establishing the current composition of the Committee as: four Teacher Members, nine Regular Members, and two Student Alternate Members; and

WHEREAS, members of the Committee must reside, work or attend public school in Hollywood and are known for their broad countywide interest in education; and

WHEREAS, persons of diverse perspectives shall be represented on the Committee, including parents of school-age or pre-school-age children, educators, business people, and persons with a background and knowledge in child development and/or education-related fields; and

WHEREAS, Dr. Daniel Derrico serves in the capacity of a Teacher Member and his term expires on June 30, 2019; and

WHEREAS, Jaqueline Grant, Donna Greene, Dr. Joel Levine and Dr. Kathy Thomas serve in the capacity of Regular Members, and their terms expire on June 30, 2019; and

WHEREAS, Khadja Gregory-Faal served in the capacity of Regular Member, and she resigned on October 16, 2018, leaving a Regular Member position vacant, and this term expires on June 30, 2021; and

WHEREAS, Emily Kriger served in the capacity of Student Alternate Member, and she resigned on April 8, 2019, leaving a Student Alternate Member position vacant, and this term expires June 30, 2019; and

WHEREAS, Graham Rubin serves in the capacity of Student Alternate Member and his term expires on June 30, 2019; and

WHEREAS, the City Clerk provided notice to the public that positions are available on the Committee and solicited interest forms from citizens to fill available vacancies; and

WHEREAS, City staff provided notice of the available positions to local public school administrators and requested administrators to notify parents and students about the opportunity to serve; and
