A RESOLUTION OF THE CITY COMMISSION OF THE CITY  
OF HOLLYWOOD, FLORIDA, APPOINTING FIVE  
MEMBERS TO THE COMMUNITY DEVELOPMENT  
ADVISORY BOARD.

WHEREAS, the City Commission passed and adopted Resolution No. R-2015-168 establishing the Community Development Advisory Board ("CDAB") consisting of 11 board members whose primary responsibility is to make recommendations to the City Commission on matters involving the Community Development Block Grant Funds, HOME funds and other federal funds that may be allocated; and

WHEREAS, pursuant to Resolution No. R-2015-168, CDAB members shall be qualified electors in the City and priority shall be given to representatives from geographical areas of the City designated as qualified by the United States Census Bureau as having greater than 51% concentrations of low/moderate income (LMI) persons; and

WHEREAS, Gilberto Amador resigned from the board and his term expires on June 30, 2019; and

WHEREAS, Michael Bentolila, Phelipe de Souza, Diana Pittarelli, and Milana Walter's terms expire on June 30, 2019; and

WHEREAS, the City Clerk provided notice to the public that positions were available and solicited interest forms from citizens to fill available vacancies; and
