A RESOLUTION OF THE CITY COMMISSION OF THE CITY
OF HOLLYWOOD, FLORIDA, APPOINTING THREE
MEMBERS TO THE CIVIL SERVICE BOARD.

WHEREAS, the Civil Service Board primarily serves as an appellate review board relating to employee suspensions, demotions or terminations, or as an appellate review board for testing, promotion or placement challenges; and

WHEREAS, the City Commission adopted the Civil Service Ordinance No. O-84-14, which was subsequently approved by referendum on March 13, 1984; and

WHEREAS, the City Commission adopted Ordinance No. O-2010-30 removing the Civil Service Ordinance from the City Charter and placing it in the Code of Ordinances, and Ordinance No. O-2010-30 was subsequently approved by referendum on November 2, 2010; and

WHEREAS, the membership criteria for the vacant seats on the Civil Service Board are as follows: first, the member must be a continuous resident of the City of Hollywood and second, must meet one of the following criteria of the vacating seats: a) an individual employed or previously employed by the private sector in the area of personnel administration; b) an individual employed or previously employed in the private sector in a non-management position; and c) an individual employed or previously employed by a public employer; and

WHEREAS, the term of Stanley Swiderski, serving as an individual employed or previously employed by the private sector in a personnel administration position, is expiring on June 30, 2019; and

WHEREAS, the term of Dr. Jalane Meloun, serving as an individual employed or previously employed in the private sector in a non-management position, is expiring on June 30, 2019; and

WHEREAS, the term of Mitchell Anton, serving as an individual employed or previously employed by a public employer, is expiring on June 30, 2019; and

WHEREAS, the City Clerk provided notice to the public and solicited interest forms from citizens to fill current and upcoming vacancies; and

WHEREAS, the following candidate has expressed interest in membership and qualifies for appointment to the Civil Service Board as an individual employed or previously employed by the private sector in a personnel administration position:

Jenny R. Adelman ; and

WHEREAS, the following candidate has expressed interest in continued membership and qualifies for re-appointment to the Civil Service Board as an individual employed or previously employed in the private sector in a non-management position:

Dr. Jalane Meloun - re-appointment ; and

WHEREAS, the following expressed interest in membership and qualifying for appointment to the Civil Service Board as an individual employed or previously employed by a public employer:

Anton Mitchell - re-appointment ; and

WHEREAS, Richard Aube has expressed interest in membership but does not qualify for appointment to the Civil Service Board because he is not a resident of the City of Hollywood.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the forgoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That _____ is appointed to the vacant seat on the Civil Service Board for a term commencing on July 1, 2019 and expiring on June 30, 2021 as an individual employed or previously employed by the private sector in a personnel administration position, and is affirmed by a 5/7th vote of the City Commission.

Section 3: That _____ is re-appointed to the vacant seat on the Civil Service Board for a term commencing on July 1, 2019 and expiring on June 30, 2021 as an individual employed or previously employed in the private sector in a non-management position, and is affirmed by a 5/7th vote of the City Commission.

Section 4: That _____ is appointed to the vacant seat on the Civil Service Board for a term commencing on July 1, 2019 and expiring on June 30, 2021 as an individual employed or previously employed by a public employer, and is affirmed by a 5/7th vote of the City Commission.

Section 5: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
