A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPOINTING FOUR MEMBERS TO THE YOUNG CIRCLE ARTSPARK ADVISORY BOARD.

WHEREAS, the Young Circle ArtsPark Advisory Board ("AAB") was created in 2006 by Resolution No. R-2006-412, and revised by Resolution Nos. R-2007-48 and R-2013-199, which changed the composition of the AAB to nine voting members, with two non-voting appointed representatives and two non-voting ex-officio members; and

WHEREAS, the two non-voting appointed representatives include one from Broward County Cultural Affairs Division and one from the Broward County Cultural Affairs Council, and the two non-voting ex-officio members are the City Manager appointee and the ArtsPark Foundation appointee; and

WHEREAS, there are currently nine voting members who serve in the following categories: one Visual Arts Field member; two Performing Arts Field members; one Extensive Art & Culture Background – Hollywood Resident member; one Arts Community At Large member; one member from Broward County School System; and three Citizenat-Large – Hollywood Residents members; and

WHEREAS, Board members are appointed based upon their interest in the arts and culture and backgrounds in the categories of visual arts, performing arts, tourism, arts community-at-large, education, and a resident with extensive art and culture background; and

WHEREAS, the purpose of the AAB is to make recommendations to the City Commission on the operational management structure, proposed facility modifications, and programming of the ArtsPark, and the AAB has no budgetary powers; and

WHEREAS, the following members terms expire on June 30, 2019: Visual Arts Field, Beverly Lewis-Fifield; Performing Arts Field, Larry Perez; and Citizen-At-Large-Hollywood Resident Field, Maurice Gosby and Steven Toth; and

WHEREAS, the City Clerk provided notice to the public that positions were available and solicited interest forms from the community to fill the current vacancies; and

WHEREAS, the following individuals have expressed a desire and willingness to fill the vacancies and serve on the Board:
