A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AMENDING RESOLUTION NO. R-2017-339 RELATING TO THE SCHEDULE OF FEES AND CHARGES FOR THE DEPARTMENT OF PARKS, RECREATION AND CULTURAL ARTS; APPROVING REVISIONS TO THE RATE SCHEDULE AND FEE STRUCTURE.

WHEREAS, the revisions requested in this Resolution seek to establish fees for items that were not present in the previous Department of Parks, Recreation and Cultural Arts' Schedule of Fees and Charges update; and

WHEREAS, the Department of Parks, Recreation and Cultural Arts ("PRCA"), on a regular ongoing, proposes changes to the Schedule of Fees and Charges consistent with costs in the local marketplace to provide such services, which supports the PRCA's recreation programs and events; and

WHEREAS, the last Schedule of Fees and Charges amendment approved by the City Commission was in September 2017 pursuant to Resolution No. R-2017-339; and

WHEREAS, the updated Schedule of Fees and Charges will help supplement the City's allocation of General Fund dollars for various programs and services within PRCA.

NOW, THEREFORE, BE IT RESOLVED, BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

<u>Section 2</u>: That it amends Resolution No. R-2017-339 and approves and authorizes the adoption of the updated Schedule of Fees and Charges for those facilities, activities, and programs as more specifically set forth in the attached Exhibit "A".

<u>Section 3</u>: That all other fees and charges set forth in the rate schedule established in Resolution No. R-2017-339 shall remain in full force and effect.

<u>Section 4</u>: That all fees and charges established by this Resolution shall be further amended annually on each October 1, starting in 2019, by the annual increase in the Consumer Price Index for all Urban Consumers in the Miami-Fort Lauderdale Metropolitan Area as of the previous June.
