A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING A TECHNICAL REVISION TO THE STATE HOUSING INITIATIVES PARTNERSHIP PROGRAM LOCAL HOUSING ASSISTANCE PLAN FOR THE STATE OF FLORIDA FISCAL YEARS 2016-2017, 2017-2018 AND 2018-2019; AMENDING THE FISCAL YEAR 2019 OPERATING BUDGET.

WHEREAS, Sections 420.907 through 420.9079, Florida Statutes, and Chapter 67-37 of the Florida Administrative Code ("FAC"), allow municipalities to receive State funds dedicated to affordable housing production and preservation; and

WHEREAS, the City has established Local Housing Assistance Plans pursuant to Chapter 160, City Code; and

WHEREAS, the Local Housing Assistance Plans have been created to support owner-occupied housing rehabilitation, demolition and reconstruction, disaster repair, tenant-based rental assistance, acquisition, disaster recovery assistance, new construction, purchase assistance and program administration; and

WHEREAS, the City desires to make Technical Revisions to the State Housing Initiative Partnerships ("SHIP") Local Housing Assistance Plan for the State of Florida Fiscal Years 2016-2017, 2017-2018 and 2018-2019, including the applicable Housing Goals Charts in the attached Exhibit "2", in order to recognize 2017-2018 and 2018-2019 Program Income, as set forth in the attached Exhibit "1"; and

WHEREAS, each local government must use a minimum of 20% percent of its SHIP allocation to serve persons with special needs as defined in Section 420.0004, Florida Statutes; and

WHEREAS, the City's Fiscal Year 2019 Operating Budget was adopted and approved by the City Commission pursuant to Resolution No. R-2018-301 at the Second Public Budget Hearing on September 26, 2018; and

WHEREAS, this Resolution also seeks to authorize the recognition and appropriation of SHIP Program Income and SHIP allocation to various eligible activities as further detailed in the attached Exhibit "1".

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING A TECHNICAL REVISION TO THE STATE HOUSING INITIATIVES PARTNERSHIP PROGRAM LOCAL HOUSING ASSISTANCE PLAN FOR STATE OF FLORIDA FISCAL YEARS 2016-2017, 2017-2018 AND 2018-2019 AMENDING THE FISCAL YEAR 2019 OPERATING BUDGET.

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes the proposed technical revisions to the relevant State Housing Initiatives Partnership Local Housing Assistance Plans for Fiscal Years 2016-17, 2017-2018, and 2018-2019, as more specifically set forth in the attached Exhibit "1" and the Housing Goals Chart, as more specifically set forth in the attached Exhibit "2".

Section 3: That the Amendments, Adjustments and Transfers to the Operating Budget for the Fiscal Year beginning October 1, 2018 and set forth in detail in the attached Exhibit "1" are adopted and authorized as Amendments to the Operating Budget of the Local Housing Assistance Trust Fund (Fund 164) of the City of Hollywood, Florida, for the Fiscal Year 2019.

<u>Section 4</u>: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
