## RESOLUTION NO.

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO BIND A FLOOD INSURANCE POLICY WITH HARTFORD INSURANCE COMPANY OF THE MIDWEST FOR FLOOD INSURANCE FOR THE CITY-OWNED SUE GUNZBURGER, WASHINGTON PARK CHILD CARE CENTER FACILITY, LOCATED AT 5731 PEMBROKE ROAD, FOR A NOT TO EXCEED AMOUNT OF \$910.00.

WHEREAS, the City is the owner of a 4,474 square foot building at 5731 Pembroke Road and adjacent 25 foot wide vacant parcel, which has been operated as a day care facility known as the Sue Gunzburger, Washington Park Child Care Center; and

WHEREAS, the Sue Gunzburger, Washington Park Child Care Center is partially impacted by a 100-year flood zone; and

WHEREAS, the City desires to secure coverage for a flood insurance product that covers the Sue Gunzburger Child Care site; and

WHEREAS, on May 15, 2019, through RFP 4606-19-AP and Resolution R-2019-116, the City designated Aon Risk Services, Inc. of Florida as its Broker of Record; and

WHEREAS, under section 38.40(C)(9) of the Code of Ordinances, purchases of insurance through the City's Broker of Record are exempt from the competitive bid and competitive proposal requirements of the Purchasing Ordinance; however, such purchases with estimated annual costs in excess of \$50,000.00 require prior approval of the governing body; and

WHEREAS, although this premium does not by itself exceed \$50,000.00, it brings the total of all premiums paid by the City to Hartford Insurance Company of the Midwest for flood insurance coverage in Fiscal Year 2019 to an amount in excess of \$50,000.00; and

WHEREAS, funding for flood insurance has been provided for in the fiscal year 2019 budget in the City's Self Insurance Fund (Fund 58), account number 558.112006.51900.591940.000000.000.000.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA.

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

<u>Section 2</u>: That it approves and authorizes the binding, by the appropriate City officials, of policies with Hartford Insurance Company of the Midwest, of flood insurance for the City-owned Sue Gunzburger, Washington Park Child Care Center, for a not to exceed amount of \$910.00, in a form acceptable to the City Manager and approved as to form and legal sufficiency by the City Attorney.

<u>Section 3</u>: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
