A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ISSUE A PURCHASE ORDER WITH TOP LINE RECREATION, INC. FOR THE PURCHASE AND INSTALLATION OF PLAYGROUND EQUIPMENT, PLAYGROUND SURFACING, AND SHADE SYSTEM AT JOE DIMAGGIO PARK, A GENERAL OBLIGATION BOND PROJECT, IN THE AMOUNT OF \$260,996.73, BASED UPON THE SCHOOL DISTRICT OF OSCEOLA COUNTY'S BID NO. SDOC-16-B-087-LH IN ACCORDANCE WITH SECTION 38.40(C)(5) OF THE PURCHASING ORDINANCE (PIGGYBACK).

WHEREAS, on March 12, 2019, City of Hollywood residents passed the General Obligation Bond ("GOB") to fund a variety of Citywide public improvement projects, including funding for improvements of Parks, Recreational and Cultural Facilities, Open Space and Golf; and

WHEREAS, the Department of Parks, Recreation and Cultural Arts requires the purchase and installation of playground equipment, playground surfacing and shade system for Joe DiMaggio Park located within the City of Hollywood; and

WHEREAS, the playground equipment, playground surfacing and shade system will be installed at Joe DiMaggio Park as part of the City's GOB Parks, Recreational and Cultural Arts Facilities Program; and

WHEREAS, the requested purchase and installation of the playground equipment, playground surfacing and shade system were competitively bid through the School District of Osceola County - Contract Number SDOC-16-B-087-LH, for a term effective April 19, 2019 through April 18, 2020, and pursuant to Bid Number SDOC-16-B-087-LH, for the use and reliance of governmental agencies within the State of Florida; and

WHEREAS, this purchase is subject to the City receiving all insurance and endorsements required and approved by the City's Risk Manager; and

WHEREAS, the Interim Director of Parks, Recreation and Cultural Arts and the Director of Procurement Services recommend that the City Commission approve issuance of a Purchase Order for the purchase and installation of playground equipment, playground surfacing and shade system from Top Line Recreation, Inc. in the amount of \$260,996.73; and

WHEREAS, Section 38.40 (C)(5) of the Purchasing Ordinance allows the Director to procure, without following formal procedures, all goods and services that are subject of contracts with the state, its political subdivisions, the United States government, other

governmental entities, or a corporation not for profit whose members are governmental entities, public officers, or any combination thereof, provided that the goods and services are: (i) the subject of a price schedule negotiated by the state or the United States government, or (ii) the subject of a contract with another governmental entity or a corporation not for profit whose members are governmental entities, public officers, or any combination thereof, which contract is based strictly on competitive bids or competitive proposals and not on any preference; and

WHEREAS, funding for this project was approved by Resolution R-2019-147, adopted June 5, 2019, that amended the FY 2019 Capital Improvement Program, including the GOB projects, and funding is available for this project in account number 333.309901.57200.563010.XXXXXXX.000.000.

NOW, THEREFORE, BE IT RESOLVED, BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

<u>Section 2</u>: That it approves and authorizes the issuance, by the appropriate City officials, of a Purchase Order with Top Line Recreation, Inc., together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.

<u>Section 3</u>: That this Resolution shall be in full force and effect as immediately upon its passage and adoption.
