A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ACCEPT SAFE PARKS AND LAND PRESERVATION BOND PROGRAM FUNDS FOR RENOVATIONS AND IMPROVEMENTS AT THE WASHINGTON PARK COMMUNITY CENTER AND THE DR. MARTIN LUTHER KING JR. COMMUNITY CENTER IN THE AMOUNT OF \$58,000.00; AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE GRANT AGREEMENTS AND ALL APPLICABLE GRANT DOCUMENTS WITH BROWARD COUNTY; AMENDING THE FY2019 ADOPTED OPERATING BUDGET.

WHEREAS, Broward County Commissioner Beam Furr wishes to utilize the \$58,000.00 in Safe Parks Funds allocated to District 6 to complete renovations and improvements at the Washington Park Community Center and the Dr. Martin Luther King Jr. Community Center in Hollywood; and

WHEREAS, on April 4, 2019, the Broward County Commission by motion approved the allocation of such funds for these projects; and

WHEREAS, the allocated grant funding will be disbursed as follows: \$32,000.00 for the Dr. Martin Luther King Jr. Community Center and \$26,000.00 for the Washington Park Community Center; and

WHEREAS, these renovations and improvements will primarily include refinishing and replacing flooring and wall padding at Washington Park and Dr. Martin Luther King Jr. Community Centers; and

WHEREAS, the Department of Parks, Recreation and Cultural Arts desires to accept the grant funding in the approximate amount of \$58,000.00; and

WHEREAS, there is no match required for this funding source; and

WHEREAS, this grant funding will be utilized to sand, refinish, painting and lining the wooden gym floors at both centers; and

WHEREAS, funding will also be utilized to replace the wall padding at both community centers for the safety of court patrons; and

WHEREAS, it is necessary to amend the approved FY 2019 Operating and Special Program Fund Plan (111) Budgets as set forth in the attached Exhibit "1".

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes the appropriate City officials to accept Safe Parks and Land Preservation Bond Program Grant funds in the amount of \$58,000.00 for the specified projects, provided that the City Manager shall have the discretion to refuse the grant in those circumstances where he determines it is in the best interest of the City to do so, in which case he shall advise the City Commission of his intention to refuse the grant(s).

Section 3: That it authorizes the execution by the appropriate City officials of the attached Agreements with Broward County, together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 4: That it authorizes the execution, by the appropriate City officials, of all other grant documents that may be applicable for these specified projects, together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 5: That these Amendments, Adjustments and Transfers of funding to the FY 2019 Operating Budget for the Fiscal Year beginning October 1, 2018 and set forth in the detail in the attached Exhibit "1" are adopted and authorized as Amendments and/or Adjustments to the various Operating Budgets of the Funds of the City of Hollywood, Florida, for Fiscal Year 2019.

Section 6: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
