A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE A MEMORANDUM OF UNDERSTANDING AMONG BROWARD COUNTY AND PARTICIPATING MUNICIPALITIES REGARDING A COLLABORATIVE STUDY AND SUBSEQUENT DEVELOPMENT OF AN INTEGRATED SOLID WASTE AND RECYCLING SYSTEM.

WHEREAS, there is an urgent need for the comprehensive regionalized management of an efficient, effective and environmentally sensitive plan for the disposal of yard waste, bulk waste, construction and demolition debris, household hazardous waste and recyclables processing; and

WHEREAS, through a Memorandum of Understanding ("MOU"), Broward County seeks a commitment to work cooperatively with participating municipalities to establish and implement an integrated and comprehensive regional solid waste disposal and recyclables processing management system to address this need; and

WHEREAS, the City is committed to working with Broward County toward establishing an integrated and comprehensive regional solid waste management system by execution of the attached MOU; and

WHEREAS, the MOU provides that such a system must be a collaborative venture based on mutual pledges of solid waste flow and a schedule that includes specific milestones for the County and City to achieve as they work toward establishing a regional solid waste and recyclables management system; and

WHEREAS, the MOU provides that future study and analysis would be based upon results of the recent study conducted by the Arcadis, U.S., Inc., Kessler Consulting, Inc., Total Municipal Solutions, L.L.C., and GMAC Consulting, L.L.C. (collectively, the "Arcadis Team"), which evaluated and made recommendations regarding reaching a 75% countywide recycling goal, the impact of continued public ownership of Alpha 250, and other general solid waste issues; and

WHEREAS, the MOU provides for an effective date of October 1, 2019, provided that no less than 50% of the County's total population approve and execute the MOU by this date.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes the execution, by the appropriate City officials, of the attached MOU among Broward County, the City and participating municipalities, together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 3: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
