ORDINANCE NO. 0-99-29

AN ORDINANCE OF THE CITY OF HOLLYWOOD, FLORIDA, AMENDING CHAPTER 50, "SOLID WASTE AND RECYCLING MANAGEMENT" BY AMENDING SECTION 50.05 OF THE CODE OF ORDINANCES TO PROVIDE THAT THE FRANCHISE FEE PAYABLE BY PRIVATE CONTRACTORS COLLECTING SOLID WASTE AND RECYCLABLES SHALL BE ESTABLISHED BY RESOLUTION OF THE CITY COMMISSION.

WHEREAS, Chapter 50 of the Code of Ordinances of the City of Hollywood, establishes the procedures and regulations for solid waste and recycling management; and

WHEREAS, the Public Works Department has reviewed the current franchise fee relating to the collection of solid waste and recycling by private contractors and has determined that said fee needs be changed; and

WHEREAS, the City Commission has previously determined that rates and fees should be adopted by resolution rather than ordinance in order to make them easier to amend; and

WHEREAS, the City Commission wishes to provide for the adoption of the franchise fee for private collection of solid waste and recyclables by resolution;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

<u>Section 1</u>: That Chapter 50, "Solid Waste and Recycling Management, " of the Code of Ordinances of the City of Hollywood is hereby amended as follows:

## TITLE V: PUBLIC WORKS

## CHAPTER 50: SOLID WASTE AND RECYCLING MANAGEMENT

## §50.05COLLECTION OF GARBAGE, RECYCLING, AND RUBBISH BY PRIVATE CONTRACTOR; PERMIT REQUIREMENTS; RECYCLING.

(F) Franchise Fee. The issuance of a permit, as described above, gives each private contractor so permitted, a franchise to collect garbage and rubbish within the city. The commercial franchise fee shall be <u>established by resolution of the City Commission</u>. effective beginning October, 1994 and shall be payable to the City in an amount equal to 10% of the gross receipts or equivalent value received for commercial collection, less allowable exemptions from gross receipts. Private Contractors shall be solely responsible for remitting payment for the franchise fee to the City based upon the **GROSS RECEIPTS** by the private contractor. The private contractor shall remit the franchise fee payment along with the remittance form which shall be provided by the Director of Financial Services or his/her designee.

\* \* \*

<u>Section 2</u>: That is the intention of the City Commission and it is hereby ordained that the provisions of this ordinance shall be made a part of the Code of Ordinances of the City of Hollywood, Florida, and the provisions of said sections may be renumbered to accomplish such intention.

<u>Section 3</u>: That if any word, phrase, clause, subsection or section of this ordinance is for any reason held unconstitutional or invalid, the invalidity thereof shall not affect the validity of any remaining portions of this ordinance.

<u>Section 4</u>: That all sections or parts of sections of the Code of Ordinances, all ordinances or parts of ordinances, and all resolutions or parts of resolutions in conflict herewith be and the same are hereby repealed to the extent of such conflict.
