A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, REVISING THE MONTHLY SANITATION FEE FOR COLLECTION AND DISPOSAL SERVICES PROVIDED BY THE ENVIRONMENTAL SERVICES DIVISION OF THE PUBLIC WORKS DEPARTMENT.

WHEREAS, on February 5, 1997, the City Commission passed and adopted Resolution No. R-97-16, establishing fees for sanitation services provided to customers and for private contractor fees; and

WHEREAS, on September 7, 1999, the City Commission passed and adopted Resolution No. R-99-297, revising the monthly fees for sanitation services provided to customers; and

WHEREAS, on September 30, 2000, the City Commission passed and adopted Resolution No. R-2000-334, amending the fees for monthly sanitation services provided to customers; and

WHEREAS, on June 2, 2004, the City Commission passed and adopted Resolution No. R-2004-184, revising the monthly fees for sanitation services provided to customers; and

WHEREAS, on May 21, 2008, the City Commission passed and adopted Resolution R-2008-119, revising the monthly fees for sanitation services provided to customers; and

WHEREAS, on October 6, 2010, the City Commission passed and adopted Resolution R-2010-297, revising the Commingled Waste Collection Fees and Other fees for services provided to customers; and

WHEREAS, on September 21, 2011, the City Commission passed and adopted Resolution R-2011-249, revising the monthly fees for sanitation services provided to customers; and

WHEREAS, the Director of Public Works desires to amend the monthly sanitation fee schedule for collection and disposal services provided by the Environmental Services Division of the Public Works Department related to the collection of solid waste, garbage, commingled waste and recyclables materials, and processing and disposal of said wastes beginning October 1, 2019.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

<u>Section 1</u>: The Resolution Nos. R-97-26, R-99-297, R-2000-334, R-2004-184, R-2008-119, R-2010-297 and R-2011-249 are amended to revise the fee schedule for services provided by the Environmental Services Divisions according to Chapter 50, "Solid Waste and Recycling Management", as follows:

(B) Monthly Fees:

(1) Single Family homes and duplex apartments. Monthly fee for twice-weekly garbage collection, bi-weekly weekly recycling collection, weekly brush collection, monthly commingled waste materials disposal, and recycling processing, shall be \$31.00 \$38.00 per month.

\* \*

Section 2: That all other fees established by Resolutions Nos. R-97-26, R-99-297, R-2000-334, R-2004-184, R-2008-119, R-2010-297 and R-2011-249 not amended by this Resolution shall remain in full force and effect.

<u>Section 3</u>: That all fees established by Resolution Nos. R-97-26, R-99-297, R-2000-334, R-2004-184, R-2008-119, R-2010-297 and R-2011-249 as amended by this and future resolutions shall be further amended based on the contractual obligations and program administration costs. Based on staff analysis, the projected aggregate sanitation fee is estimated to be adjusted as follows, however, the actual increase would be determined on an annual basis based on contractual obligations and program administration costs: <u>October 1, 2020, increase shall be 6.43%; October 1, 2021, increase shall be 5.32%; October 1, 2022, increase shall be 3.56%; and effective on each October 1 starting October 1, 2023 through October 1, 2029, increase shall be 2.50%, annually.</u>

<u>Section 4</u>: That this Resolution shall be in full force and effect on October 1, 2019.
