A RESOLUTION OF THE HOLLYWOOD, FLORIDA COMMUNITY REDEVELOPMENT AGENCY ("CRA"), AUTHORIZING THE APPROPRIATE CRA OFFICIALS TO ISSUE A PURCHASE ORDER WITH PAINT QUEST, LLC. TO PAINT DECORATIVE INTERSECTIONS AND CROSSWALKS ON SPECIFIC LOCATIONS IN THE DOWNTOWN CRA DISTRICT IN AN AMOUNT NOT TO EXCEED \$75,000.00.

WHEREAS, the concept of painting intersections and crosswalks located within the Downtown CRA District was initiated by the Parkside Civic Association; and

WHEREAS, on December 6, 2017, the concept was presented to the CRA Board as part of the Parkside Pride Improvement Project presentation; and

WHEREAS, the CRA issued a call to artists to submit design concepts for the intersections and crosswalks, and received 58 responses that were deemed qualified; and

WHEREAS, the Mural Review Committee identified the four winning designs for the four intersections and crosswalks located at 19th and 20th Avenues and Van Buren and Polk Streets; and

WHEREAS, the CRA desires to contract the service of painting specific graphic designs on the four intersections with Paint Quest, LLC.; and

WHEREAS, on June 26, 2019, Notice of Availability of Quote Number 1906-001 was posted on the City's website, advertised and sent to 4,067 firms, and viewed by 40 vendors on Bidsync.com in accordance with the City's Purchasing Ordinance, Section 38.42 (A)(1); and

WHEREAS, Quote Number 1906-001 was opened on July 15, 2019, and resulted in responses from two bidders:

•	Paint Quest, LLC. Ocoee, Florida	\$75,000.00
•	Razorback, LLC. Tarpon Springs, Florida	\$154,000.00

; and

WHEREAS, Paint Quest, LLC. met all the bid specifications and the CRA recommends this service receive the award; and

WHEREAS, the CRA Executive Director and the Director of Procurement and Contract Compliance recommend that the CRA Board approve the issuance of a Purchase Order for all aspects of the service of painting decorative intersections and crosswalks on four intersections and crosswalks located at 19th and 20th Avenues and Van Buren and Polk Streets to Paint Quest, LLC. for a one-time purchase in an amount not to exceed \$75,000.00; and

WHEREAS, the CRA may terminate the agreement with or without cause upon 30 days written notice; and

WHEREAS, award is subject to the CRA and City receiving all insurance and endorsements required and approved by the City's Risk Manager, along with signed statements of Hold Harmless and Indemnity to the City and CRA; and

WHEREAS, funding for the agreement has been provided in the Fiscal Year 2019 Budget Account Number 166.669902.55200.563010.001111.000.000.

NOW, THEREFORE, BE IT RESOLVED BY THE HOLLYWOOD, FLORIDA COMMUNITY REDEVELOPMENT AGENCY:

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in the Resolution.

<u>Section 2</u>: That it approves and authorizes the issuance, by the appropriate CRA officials, of a purchase order with Paint Quest, LLC., together with such nonmaterial changes as may be subsequently agreed to by the Executive Director and approved as to form and legal sufficiency by the CRA General Counsel.

<u>Section 3</u>: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
