Explanation:

The CRA require the services of a consultant to provide surveying and mapping services in order to implement the Phase 4 Streetscape and A1A Project in an expeditious fashion. The CRA followed the procedures established in the Florida Statutes, Section 287.055, Consultants' Competitive Negotiation Act, to procure services from such a consulting firm and advertised for Professional Services from mapping and surveying services consulting firms.

Statements of Qualifications were received from nine (9) firms and reviewed by an Evaluation Committee comprised of in-house professionals, more specifically, one Director, one Senior Project Manager and one Project Manager.

The cumulative amount of fees to be paid for services provided by the consultant under this contract shall not exceed \$1,000,000.00, and all related capital costs are subject to review and approval of the CRA Board prior to commencement of the project.
