WHEREAS, the City Commission desires to change the regularly scheduled Wednesday, April 15, 2020 meeting to Wednesday, April 22, 2020, with citizens' comments at 5:00 P.M., due to Passover; and

WHEREAS, the City Commission desires to add citizens' comments at 5:00 P.M. on the regularly scheduled Wednesday, July 1, 2020 meeting due to moving the July 15, 2020 Commission meeting; and

WHEREAS, the City Commission desires to change the regularly scheduled Wednesday, July 15, 2020 meeting to Wednesday, August 26, 2020, with citizens' comments at 5:00 P.M., to allow more time for next year's fiscal budget preparation; and

WHEREAS, the City Commission desires to add citizens' comments at 5:00 P.M. on the regularly scheduled Wednesday, December 2, 2020 meeting due to cancelling the December 16, 2020 Commission meeting; and

WHEREAS, the City Commission desires to cancel the regularly scheduled Wednesday, December 16, 2020 meeting due to the holidays; and

WHEREAS, the City Commission desires to cancel the regularly scheduled Wednesday, January 6, 2021 meeting.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

<u>Section 2</u>: That the regular meeting of the Hollywood City Commission scheduled on April 15, 2020 shall be rescheduled in the City Commission Chambers at City Hall, 2600 Hollywood Boulevard, to Wednesday, April 22, 2020 at 1:00 P.M., with citizens' comments at 5:00 P.M.

<u>Section 3</u>: That the regular meeting of the Hollywood City Commission scheduled on July 1, 2020 shall have citizens' comments at 5:00 P.M.

<u>Section 4</u>: That the regular meeting of the Hollywood City Commission scheduled on July 15, 2020 shall be rescheduled in the City Commission Chambers at City Hall, 2600 Hollywood Boulevard, to Wednesday, August 26, 2020 at 1:00 P.M., with citizens' comments at 5:00 P.M.

<u>Section 5</u>: That the regular meeting of the Hollywood City Commission scheduled on December 2, 2020 shall have citizens' comments at 5:00 P.M.

<u>Section 6</u>: That the regular meeting of the Hollywood City Commission scheduled on December 16, 2020 shall be cancelled.

<u>Section 7</u>: That the regular meeting of the Hollywood City Commission scheduled on January 6, 2021 shall be cancelled.

<u>Section 8</u>: Thereafter, regular meetings of the City Commission shall, unless otherwise provided by Resolution, be held on the first and third Wednesdays of each month.
