FOR THE DEVELOPMENT OF FY 2018 LARGE USER TRUE-UP RELATED REPORTS AND FY 2020 LARGE USER RATE ESTIMATE, IN THE AMOUNT OF \$67,320.00.

WHEREAS, the City is required to perform the annual Large User True-up Reports (Large User True-up and RRI True-up) and the FY 2019 Large User Rate Estimate per the Large User Agreement dated October 1, 1990; and

WHEREAS, the Department of Public Utilities requested a proposal from Lighthouse Utility Consulting to provide consulting services with regard to various water and sewer rates, financial analysis and revenue projections, various financial reports, installation and training on a rate model to be used for all rate studies and financial projections and true-up report, and other services as detailed in RFQ No. 4464-15-RL; and

WHEREAS, on August 26, 2015, the City Commission passed and adopted Resolution No. R-2015-250, which authorized the negotiation and execution of a three year agreement with Lighthouse Utility Consulting to provide consulting services for the services set forth in RFQ No. 4464-15-RL; and

WHEREAS, Lighthouse Utility Consulting and the City have an existing Professional Services Agreement for Consulting Services dated November 16, 2015, which expires on November 15, 2018; and

WHEREAS, pursuant to Section 38.48(C)(1) of the Purchasing Ordinance, the City Manager approved the renewal of the existing agreement for an additional three years effective November 15, 2018; and

WHEREAS, administration recommends that the City Commission authorize the appropriate City officials to execute the attached Authorization to Proceed for Work Order No. LH-19-01 with Lighthouse Utility Consulting in the amount of \$67,320.00; and

WHEREAS, funding in the amount of \$67,320.00 is available from account number 42.4001.00000.536.003130.
