A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ISSUE A BLANKET PURCHASE ORDER WITH USA FENCE COMPANY FOR FRENCH BARRICADE RENTALS IN AN ESTIMATED ANNUAL AMOUNT OF \$55,852.24 BASED UPON THE CITY'S BID NO. F-4624-19-RL.

WHEREAS, the Department of Parks, Recreation & Cultural Arts requires the services provided by USA Fence Company; and

WHEREAS, on September 16, 2019, Bid Number F-4624-19-RL French Barricade Rentals was electronically advertised on BidSync in accordance with Section 38.42 (A) of the City's Purchasing Ordinance; and

WHEREAS, two registered BidSync vendors downloaded the solicitation for further consideration; and

WHEREAS, as of the solicitation due date, two potential vendors viewed the solicitation on BidSync; and

WHEREAS, on October 8, 2019, F-4624-19-RL was opened and resulted in the following responses:

USA Fence Company \$55,852.24 RoadSafe Traffic Systems, Inc. \$81,996.00

; and

WHEREAS, USA Fence Company has been determined to be the lowest responsive, responsible bidder; and

WHEREAS, USA Fence Company is currently providing these services to the City in a responsive and satisfactory manner; and

WHEREAS, the term of this blanket purchase order shall be for an initial three year period and may be renewed for two additional one year renewal periods; and

WHEREAS, the Directors of Parks, Recreation & Cultural Arts and Procurement & Contract Compliance recommend that the City Commission approve the issuance of a blanket purchase order for French Barricade Rentals to USA Fence Company, in an estimated annual amount of \$55,852.24; and

WHEREAS, award is subject to the City's receipt and approval of all insurance certificates and endorsements required by the City's Risk Manager; and

WHEREAS, funding for the purchase has been appropriated and exists in account number 163.638507.55200.549110.000000.000.000.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

<u>Section 2</u>: That it approves and authorizes the issuance, by the appropriate City officials, of a blanket purchase order with USA Fence Company, together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.

<u>Section 3</u>: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
