A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE PAYMENT OF FEES TO GRAYROBINSON P.A. FOR LEGAL SERVICES TO DEVELOP REGULATIONS FOR 5G TECHNOLOGY IN THE NOT TO EXCEED AMOUNT OF \$37,500.00.

WHEREAS, 5G technology has been developed in recent years and is a fast growing industry; and

WHEREAS, 5G technology requires installation of numerous poles throughout the City by various telecommunication companies; and

WHEREAS, the City desires to develop regulations that would be applicable to the 5G installations throughout the City; and

WHEREAS, the law firm GrayRobinson P.A. has been working on developing similar regulations for other municipalities, and staff recommends that the City retain the firm to draft the subject ordinance; and

WHEREAS, the City is already using GrayRobinson P.A. for lobbying and the Icon litigation, and is paying the firm more than \$50,000.00 for the two existing matters, and thus, the Purchasing Ordinance requires City Commission approval for the payment of additional fees for this matter; and

WHEREAS, funding is available in the FY 2019 budget account number 001.140202.51500.531300.00000.000.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes the payment, by the appropriate City officials, of attorney's fees pursuant to the attached agreement with GrayRobinson, P.A. for legal services to develop a 5G ordinance in an amount not to exceed \$37,500.00, together with such non-material changes as may be acceptable to the City Manager and approved as to form and legal sufficiency by the City Attorney.

<u>Section 3</u>: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
