Re: Proposal For Ordinance Development

Dear Ms. Behmardi:

Thank you for reaching out. Pursuant to our discussions, this provides our proposal to represent the City of Hollywood ("City") in developing an appropriate ordinance to implement revisions to Florida Statutes addressing communications facilities, including but not limited to small wireless facilities, in the City's public rights-of-way. As we discussed, I have given presentations on this topic at various conferences, including the Florida Municipal Attorneys Association and the Florida League of Cities, and assisted numerous governments, consistent with their unique concerns.

Fees:

We will bill the City \$385/hour for my services and other shareholders and \$225/hour for of counsels/associates working under my supervision. These represent significant discounts from our standard rates. We anticipate that our services for this project will not exceed \$37,500 in hourly fees, including attending four anticipated meetings. This is broken down as follows:

Preparation of draft ordinance and meeting with City staff:
Estimated hourly fees: \$20,000

Attending four (4) meetings: industry stakeholders, City staff, first Commission hearing (which needs 10-days advance notice to the Secretary of State), and second Commission hearing on the Ordinance; and revising the Ordinance as appropriate. Estimated hourly fees: \$17,500



In addition to fees, there may be outside costs for this project, such as travel and similar costs that we will include in our invoices. Of course, we would perform other services related to this project as requested, including attending additional meetings and training for implementation of the Ordinance.

Ms. Mertens-Black also requested that I provide a presentation to the Commission, similar to the presentation I provided at the League conference, which I am happy to schedule without cost to the City. In other respects, the terms of our engagement will continue to apply.
