A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING THE "HOLLYWOOD CROSSINGS" PLAT, BEING IN THE CITY OF HOLLYWOOD, BROWARD COUNTY, FLORIDA, AND GENERALLY LOCATED AT THE SOUTHWEST CORNER OF HOLLYWOOD BOULEVARD AND STATE ROAD 7.

WHEREAS, the Petitioner, Pulice Land Surveyors, Inc., acting on behalf of the owner, Southwest Holly LLC., has submitted application P-19-05 for review and approval of a Plat to be known as the "Hollywood Crossings", as more specifically described in the attached Exhibit "A"; and

WHEREAS, the owner has initiated development approvals to construct a Wawa Service Station consisting of a 6,119 square foot convenience store and a 20 fuel pump gas station; and

WHEREAS, Article 6 of the City's Zoning and Land Development Regulations requires that plats be submitted to the City Commission for consideration of approval, and the City's Subdivision Review Committee has reviewed the proposed plat application P-19-05 and has determined it to be consistent with the code requirements; and

WHEREAS, the Petitioner intends to file the plat amendment with Broward County.
