A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ISSUE A BLANKET PURCHASE ORDER TO CONDO ELECTRIC MOTOR REPAIR, CORP. FOR ELECTRIC MOTOR AND PUMP REPAIR SERVICES IN AN ESTIMATED ANNUAL AMOUNT OF \$220,000.00 BASED UPON THE CITY OF PLANTATION'S SOLICITATION NO. ITB-062-17 PURSUANT TO SECTION 38.40(5) OF THE CITY OF HOLLYWOOD'S PURCHASING ORDINANCE.

WHEREAS, the Department of Public Utilities requires motor and pump repair services; and

WHEREAS, the required services were competitively bid by the City of Plantation, Florida, pursuant to its Solicitation No. ITB 062-17; and

WHEREAS, on June 13, 2018, the City of Plantation awarded the bid to the lowest responsive and responsible bidder, Condo Electric Motor Repair, Corp. ("Condo"), for a two year initial term with two additional one year renewal periods; and

WHEREAS, Condo is currently providing similar services to the City of Hollywood in a satisfactory manner; and

WHEREAS, Condo has agreed to extend the same pricing, terms and conditions to the City of Hollywood as provided to in the City of Plantation's Solicitation; and

WHEREAS, the Director of Public Utilities and the Director of Procurement & Contract Compliance recommend that the City Commission approve the issuance of a blanket purchase order for Electric Motor and Pump Repair Services to Condo Electric Motor Repair, Corp. in an estimated annual amount of \$220,000.00; and

WHEREAS, Section 38.40 (C)(5) of the Purchasing Ordinance allows the Director to procure, without following formal procedures, all goods and services which are subject of contracts with the state, its political subdivisions, the United States government, other governmental entities, or a corporation not for profit whose members are governmental entities, public officers, or any combination thereof, provided that the goods and services are (i) the subject of a price schedule negotiated by the state or the United States government, or (ii) the subject of a contract with another governmental entity or a corporation not for profit whose members are governmental entities, public officers, or any combination thereof, which contract is based strictly on competitive bids or competitive proposals and not on any preference; and

WHEREAS, award is subject to the City's receipt and approval of all insurance certificates and endorsements set forth in the City of Plantation's solicitation; and

WHEREAS, funding for this Agreement has been provided for the Fiscal Year 2020 budget in the Department of Public Utilities in multiple account numbers.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

<u>Section 2</u>: That it approves and authorizes the issuance, by the appropriate City officials, of a blanket purchase order with Condo Electric Motor Repair, Corp., together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 3: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
