A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ISSUE A BLANKET PURCHASE ORDER WITH THOMPSON PUMP AND MFG CO., LLC. FOR THE PURCHASE OF A TRAILER MOUNTED HIGH EFFICIENCY, LOW PRESSURE BASED UPON THE FLORIDA ASSOCIATION SOLICITATION NO. FSA-19-VEH17.0 AND PURSUANT TO SECTION 38.40(C)(5) OF THE CITY'S PURCHASING ORDINANCE (PIGGYBACK) FOR AN ESTIMATED AMOUNT OF \$110,938.00.

WHEREAS, the Department of Public Utilities is requesting to purchase a trailer mounted high efficiency, low pressure pump for use during emergency high tides, flooding, as well as for general pumping and construction repairs within the City; and

WHEREAS, the requested pump was competitively bid through the Florida Sheriff's Association pursuant to Solicitation Number FSA-19-VEH17.0, Southern Zone, Specification #171 – Heavy Trucks & Equipment, that was opened on October 1, 2019, and was awarded to Thompson Pump and MFG Co., LLC ("Thompson Pump") for a one year contract; and

WHEREAS, Thompson Pump has agreed to provide the pump as listed in the Florida Sheriff's Association solicitation to the City under the same pricing, terms and conditions; and

WHEREAS, the Director of Public Utilities and the Director of Procurement & Contract Compliance recommend that the City Commission approve the issuance of a blanket purchase order to Thompson Pump for a Trailer Mounted High Efficiency, Low Pressure Pump in an estimated amount of \$110,938.00; and

WHEREAS, Section 38.40 (C)(5) of the Purchasing Ordinance allows the Director to procure, without following formal procedures, all goods and services that are subject of contracts with the state, its political subdivisions, the United States government, other governmental entities, or a corporation not for profit whose members are governmental entities, public officers, or any combination thereof, provided that the goods and services are (i) the subject of a price schedule negotiated by the state or the United States government, or (ii) the subject of a contract with another governmental entity or a corporation not for profit whose members are governmental entities, public officers, or any combination thereof, which contract is based strictly on competitive bids or competitive proposals and not on any preference; and
