A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXTEND THE AGREEMENT WITH EL GRAN CAFECITO, INC., D/B/A ALEXANDRA'S, TO PROVIDE FOOD AND BEVERAGE SERVICES AT CITY HALL FOR NINE MONTHS THROUGH DECEMBER 4, 2020.

WHEREAS, food and beverages continue to be an essential service for City staff and residents who conduct business at City Hall; and

WHEREAS, per Resolution R-2018-148, the City Commission approved an Agreement with Laura's and Lolitas, D/B/A Alexandra's, for the provision of food and beverage services from December 5, 2018 to December 4, 2019; and

WHEREAS, in November 2018, Laura's and Lolitas, D/B/A Alexandra's, sold their business to El Gran Cafecito, Inc., D/B/A Alexandra's ("El Gran"); and

WHEREAS, per Resolution R-2018-373, the City Commission approved an Agreement with El Gran for the period from March 12, 2019 through December 4, 2019; and

WHEREAS, the City Manager issued Memorandum No. PR-20-34, which authorized an extension of food and beverage services through March 4, 2020; and

WHEREAS, pursuant to Section 38.48(B) of the Procurement Code, the City Manager or designee is authorized to extend, for operational purposes only and for a maximum of 90 days, any contract entered into by the city pursuant to City Commission approval; and

WHEREAS, a nine month extension is being requested to continue food and beverage services through December 4, 2020 while staff determines a competitive follow-up contract for food and beverage services, to include profit sharing opportunities and healthier food options; and

WHEREAS, El Gran continues to provide satisfactory food and beverage service for the City and will continue to maintain the proper insurance requirements.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

<u>Section 2</u>: That it approves and authorizes a nine month extension of the agreement with El Gran Cafecito, Inc., D/B/A Alexandra's, for the continuance of food and beverage services, together with such non-material changes as may be acceptable to the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 3: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
