A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ISSUE A PURCHASE ORDER WITH MULLINGS ENGINEERING SERVICES, INC. FOR SOD AND SOD INSTALLATION FOR WASHINGTON PARK IN ACCORDANCE WITH SECTION 38.46 OF THE CODE OF ORDINANCES (COOPERATIVE PURCHASING), BASED ON CITY OF BOYNTON BEACH CONTRACT, FOR AN ESTIMATED EXPENDITURE OF \$103,680.00.

WHEREAS, the Department of Parks Recreation and Cultural Arts requires replacement of the natural grass fields located at Washington Park, to be performed by Mullings Engineering Services, Inc. ("Mullings"); and

WHEREAS, the required turf was competitively bid by the City of Boynton Beach, Florida, who acted as the lead agency on behalf of the Southeast Florida Governmental Purchasing Cooperative Group Bid # 033-2730-18/IT, of which the City of Hollywood is a member; and

WHEREAS, Mullings is the authorized sod contractor of Celebration Bermuda sod for the City; and

WHEREAS, Mullings will be utilized to replace and/or repair the existing sod with Celebration Bermuda sod; and

WHEREAS, award is subject to the City's receipt and approval of all insurance certificates and endorsements required by the City's Risk Manager, and indemnity to the City; and

WHEREAS, the Director of Parks Recreation and Cultural Arts and the Director of Procurement & Contract Compliance recommend that the City Commission issue a Purchase Order to Mullings for an estimated expenditure of \$103,680.00; and

WHEREAS, Section 38.46 of the Purchasing Ordinance provides that the Director shall have the authority to join with other governmental entities in cooperative purchasing plans when it serves the best interest of the City; and

WHEREAS, funding for this project is available in account number 333.309901.57200.563010.001202.000.000.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes the issuance, by the appropriate City officials, of a Purchase Order with Mullings Engineering Services, Inc., together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 3: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
