

BUS BENCH AND BUS SHELTER AGREEMENT

This Agreement made and entered into on this _____ day of _____, 2020, by and between the City of Hollywood a municipal corporation of the State of Florida, ("CITY") and SUNSHINE STATE Media, Inc., a corporation authorized to do business in the State of Florida whose principal place of business is located in 150 NW 70th Avenue, Plantation, Florida 33317 and whose Federal I.D. No. is 260-34-5811 (hereinafter "SUNSHINE STATE").

WITNESSETH:

WHEREAS, on _____, the CITY Commission passed and adopted Resolution No. R-2020-_____ that approved and authorized the execution of a five year agreement between the CITY and SUNSHINE STATE relating to bus benches and bus shelter maintenance; and

WHEREAS, the parties hereto desire to set forth in this Agreement the terms and conditions of their relationship.

NOW THEREFORE, in consideration of the mutual promises herein contained in this Agreement, the parties agree as follows:

1. The term of this Agreement shall be five years from the date of execution of this Agreement, with an option to renew for one additional five year term under the same terms and conditions, which may be exercised by mutual consent of SUNSHINE STATE and the CITY.
2. Scope of Services - SUNSHINE STATE's responsibility under this Agreement is to provide all labor, materials, equipment and services necessary for providing, installing, and maintaining a bus bench/bus shelter program which includes a maintenance program within the City as more specifically set forth in the Scope of Work/Specifications detailed in the attached Exhibit "A". SUNSHINE STATE shall ensure the timely performance of the tasks contemplated in the Scope of Work/Specifications listed in Exhibit "A".
3. Payments shall follow the Payment Schedule set forth in Exhibit "A".
4. In consideration of the permissions hereby granted to SUNSHINE STATE, SUNSHINE STATE agrees to indemnify, hold harmless and defend the CITY and the Florida Department of Transportation, their officers, agents and employees, from and against any and all claims, suits, actions, damages and causes of action whatsoever, arising during the term of this Agreement and resulting in personal injury, loss of life or damage to property sustained by any person or entity, through or as a result of the doing of any work herein authorized or the

failure to do any work herein required. These provisions shall survive the expiration or earlier termination of this Agreement. Nothing in this Agreement shall be construed to affect in any way the CITY's rights, privileges, and immunities under the doctrine of "sovereign immunity" and as set forth in Section 768.28, Florida Statutes.

5. SUNSHINE STATE shall provide the CITY's Risk Manager with Certificates of Insurance along with copies of its insurance policies, reflecting evidence of the required insurance. These Certificates shall contain a provision that coverage afforded under the policies will not be canceled until at least 30 days prior written notice has been given to the CITY. Policies shall be issued by companies authorized to do business under the laws of the State of Florida and shall have adequate Policyholders and Financial ratings in the latest ratings of A.M. Best and be part of the Florida Insurance Guarantee Association Act.

Insurance shall be in force upon the execution date of this Agreement and shall continue for the duration of this Agreement. In the event that the Insurance Certificate provided indicates that the insurance shall terminate and lapse during the period of this Agreement, SUNSHINE STATE shall furnish, at least 30 days prior to the expiration of the date of insurance, a renewed CERTIFICATE OF INSURANCE as proof that equal and like coverage for the balance of the period of the Agreement and any extension thereof is in effect.

SUNSHINE STATE shall provide the CITY with general liability insurance for bodily injury and property damage to protect the CITY against damage, costs and attorney's fees arising out of accidents or occurrences of any kind on or about the bus bench and the site. The insurance liability shall have general liability limits of (\$1,000,000.00 for injury or death and \$50,000.00 for property damage per occurrence. The above coverage must be maintained in force at all times during the term of this Agreement. The City must be named as an additional insured on all such policies, as its interest may appear.

6. SUNSHINE STATE hereby agrees that it shall comply with all federal, state, local laws and the including the City's Code of Ordinances.
7. All notices, requests, demands and other communications under this Agreement shall be in writing and shall be deemed to have been duly given if delivered personally, or if mailed, by first class mail, registered or certified, postage prepaid, addressed to the respective party at the following addresses:

8. Default/Termination.

(a) In the event of the breach of any of the covenants, terms and conditions of this Agreement by SUNSHINE STATE, CITY shall give written notice of such breach to SUNSHINE STATE to cure the breach. Upon receipt of notification, SUNSHINE STATE shall have 30 days to cure the default, except as otherwise provided in this Agreement. In the event that SUNSHINE STATE shall fail to cure the default within the 30 day period, the CITY may terminate this Agreement.

(b) This Agreement may be terminated without notice in the event of threat to the public health or the public safety as may be determined by the federal, state or local officials charged with the making of such determinations. The CITY shall not be liable to SUNSHINE STATE for any losses incurred by reason of such termination.

(c) SUNSHINE STATE shall remove all its benches within 30 days of termination or expiration of this agreement.

9. SUNSHINE STATE shall not assign transfer or sublet this Agreement or its rights, title or interest thereunder without the CITY's prior written approval, other than to an entity with the same ownership.
10. This Agreement shall be interpreted and enforced pursuant to the laws of the State of Florida. Any claims, objections or disputes arising out of the terms of this Agreement shall be litigated in Broward County Florida. No remedy conferred upon any party is intended to be exclusive of any other remedy and each and every such remedy shall be cumulative and shall be in addition to every other remedy given hereunder or now or hereafter existing at law or in equity or by statute or otherwise. No single or partial exercise by any party of any right, power or remedy shall preclude any other or further exercise of such rights.
11. The invalidity or unenforceability of any provision of this Agreement shall not affect the validity or enforceability of the remaining provisions.
12. This Agreement and its Exhibits set forth the entire agreement between the parties and there are no promises or understandings other than those stated herein. No amendment, modification or alteration will be allowable except by written instrument of the parties, approved by the City Commission and executed with all the formalities of this Agreement.

EXHIBIT "A"

SCOPE OF WORK/SPECIFICATIONS:

A. SUSHINE STATE currently furnishes and maintains bus benches at 208 designated bus bench locations, of which the temporary bus bench design will be phased out as part of this Agreement. It is acknowledged and understood that the overall program location total will vary, however, at all times a minimum of 200 designated bus benches/bus shelters will be maintained. Further, the City may request additional bus bench/bus shelter installations at bus stop locations not previously identified and Sunshine State shall install the requested bus bench/bus shelter within one month of the request. The current Bus Bench and Bus Shelter Inventory is set forth in Attachments 2 and 3 to this Exhibit.

Prior to the installation of any bench within the City of Hollywood limits, SUNSHINE STATE shall confirm in the field with a designee from the Engineering, Transportation & Mobility Division the exact placement for each bus bench/bus shelter together with an installation date. A written notice shall be provided to the Engineering, Transportation & Mobility Division within 30 days of any removal of a bus bench/bus shelter by SUNSHINE STATE.

B. INSTALLATION, MAINTENANCE AND OWNERSHIP OF BENCHES.

SUNSHINE STATE shall replace existing bus benches in accordance with the installation schedule set forth below. The installation and maintenance of the bus benches and bus shelters shall be at SUNSHINE STATE's sole cost and expense.

C. SUNSHINE STATE shall coordinate permitting and installations with other governmental agencies as may be necessary. No bus bench shall be placed at any location without the prior approval of the CITY and other jurisdictional agencies as appropriate as to its location and placement. Further, bus benches/bus shelters are to be designed to comply with the provisions of the American Disabilities Act (ADA) concerning clearance and wheelchair accessibility as well as the requirements in Section 337.408, Florida Statutes. In addition, SUNSHINE STATE will obtain the appropriate agency approval, prior to the installation of any bus bench/bus shelter in a public right-of-way under the jurisdiction of either the Florida Department of Transportation or Broward County.

D. SUNSHINE STATE shall provide all required permits, labor, materials, equipment and services necessary for the installation and maintenance of the Bus Bench/Bus Shelter Program for the CITY. Any substitution or variance to an approved bus bench/bus shelter without prior CITY approval shall constitute a default on the part of SUNSHINE STATE.

E. SUNSHINE STATE shall install the bus benches/bus shelters in the designated locations established by the CITY based upon the approved bus bench/bus shelter designs set forth in Attachment "1" of this Exhibit. The CITY reserves the right to deny specific locations at its sole discretion. It is understood that the bus

benches/bus shelters shall be placed parallel to the roadway to achieve the maximum pedestrian safety and convenience.

F. TRASH RECEPTACLES. SUNSHINE STATE shall provide, at no cost to the CITY, a trash receptacle for each bus bench/bus shelter in accordance with the Trash Receptacle Design" as set forth in Attachment "1" of this Exhibit. The trash receptacles must adhere to the requirements set forth in Section 337.408, Florida Statutes. It will be SUNSHINE STATE's responsibility to ensure, at its sole expense that the site of the bus benches/bus shelters will not become overgrown with grass or weeds or littered with debris. All bus benches/bus shelters will be maintained a minimum of three times a week or more frequently as necessary including cleaning, weed and trash removal for a radius of 10 feet from the bus bench/bus shelter and trash receptacle. SUNSHINE STATE guarantees removal or replacement of damaged bus benches/bus shelters and/or trash receptacles within 24 hours. Emergency service will be provided within 12 hours of notification. Failure to properly maintain the bus bench/bus shelter, the trash receptacle or the surrounding area will constitute cause for cancellation of the permit concerned and removal of the bus bench.

The CITY shall have the right to inspect the locations periodically to determine their condition. SUNSHINE STATE shall replace or recondition, to the satisfaction of the CITY, any bus benches/bus shelters or trash receptacles, which the CITY determines are no longer in good and serviceable condition. The CITY may elect to maintain the bus bench/bus shelter or surrounding area if SUNSHINE STATE fails to consistently comply with maintenance standards and charge back the costs to SUNSHINE STATE.

G. REMOVAL OF BUS BENCHES/BUS SHELTERS. During the term of this Agreement, the CITY may request the removal of any bus bench/bus shelter from a designated location and SUNSHINE STATE shall remove the bus bench/bus shelter within six months of the request without cost or penalty to the CITY other than the reduction in revenue based upon the number of bus benches/bus shelters. Further, in the event that the Florida Department of Transportation notifies the CITY that any bus benches or shelters need to be removed or relocated, such removal shall occur within 60 days after written notification.

Any reconstruction or construction at or in close proximity to the location of a SUNSHINE STATE bus bench or bus shelter may require the removal of same as determined by the CITY and coordination with the Engineering, Transportation & Mobility Division is required for any relocations and re-installation. Any such removal, relocation or reinstallation shall be accomplished at no cost or penalty to the CITY other than the reduction of the City's bus bench/bus shelter revenue.

H. ADVERTISING. SUNSHINE STATE will be authorized to sell advertising to be placed upon all the public benches, provided, however, there shall be no X-rated movies, tattoo parlors, loan bondsmen, massage parlors, adult movie houses or adult entertainment centers advertised upon the public benches. No

advertising shall contain material which the CITY considers immoral, lascivious, obscene, indecent, in bad taste or in violation of community standards of decency.

SUNSHINE STATE will provide, install and maintain, at its sole cost and expense, high quality, expertly designed commercial advertising displays on bus benches approved and designated by the CITY. The advertising display shall consist of one advertising panel not to exceed 12 square feet in area integral to each installation. Whenever possible, the installation of advertising displays, devices and materials will take place during hours of minimum passenger activity. Advertising displays shall not contain high intensity or neon color schemes. City shall have the sole discretion in determining compliance with this color provision. Advertising displays shall not include a portrait of a person.

I. SUNSHINE STATE will provide at its expense, a local 24-hour emergency Hotline to address calls relating to the bus bench program. The Hotline number will be clearly marked on all benches along with the bench identification number. Sufficient telephone lines will be secured so that incoming calls have reasonable free access to the SUNSHINE STATE 24-hour Hotline. Questions, requests and complaints from the public that are received by the CITY will be referred to SUNSHINE STATE at the number provided.

J. SAFETY/CONVENIENCE MEASURES. The following safety/convenience criteria shall be applicable to all bus bench/bus shelter installations:

- 1) All bus benches and bus shelters may be installed parallel with the adjacent roadway or at an angle with the adjacent roadway pursuant to Resolution No. R-2011-331.
- 2) A minimum six foot setback from the adjacent roadway or edge of driveway shall be maintained wherever possible. In curbed roads, a minimum 36-inch setback from the back of curb shall be maintained.
- 3) A minimum three foot sidewalk clearance shall be maintained.
- 4) Benches shall not be located within 25 feet of a right-of-way intersection corner, fire hydrant, fire or police call box or any other emergency facility.
- 5) No bench shall be placed in the median of a divided highway.
- 6) No advertising placed upon any bench shall imitate or resemble an official traffic control device, such as a "stop" or "yield" sign.
- 7) Only one bench per bus stop will be allowed except at CITY approved locations. Approved locations are at the sole discretion of the CITY. Any bench deemed to endanger life or property by the CITY shall be removed within 24 hours from notification of same at no cost or penalty to the CITY other than the reduction in per bench revenue.

K. All bus benches and bus shelters not complying with the provisions of this Agreement shall be corrected by SUNSHINE STATE within seven days after notification by the CITY or as set forth in this Exhibit. If SUNSHINE STATE fails to remove the bus e benches/bus shelters the CITY reserves the right to remove them at the sole cost to SUNSHINE STATE.

L. Bus Shelter Maintenance for Shelters Owned by City.

Site Maintenance- It will be SUNSHINE STATE's responsibility to ensure, at its sole expense, that the site of the shelters will not be allowed to become overgrown with grass or weeds or littered with debris. SUNSHINE STATE will maintain each shelter in a good state of repair and appearance, and the area surrounding each will be kept free of debris, high grass, weeds and other rubbish for a radius of 10 feet from the perimeter of the shelter.

Shelter Maintenance – SUNSHINE STATE will ensure that shelters are maintained in a structurally safe and cosmetically attractive condition. This condition will include maintaining the shelter seating and all sides in clean and usable condition, and required replacement of parts provided by the City. SUNSHINE STATE shall empty the trash receptacle three times a week or sooner based upon need. SUNSHINE STATE is required to keep a timely record of all maintenance performed that includes a list of the shelter location, the type of work performed and the date performed. The City reserves the right to audit such records at any time. In the event damage to a shelter results in it becoming a safety hazard, SUNSHINE STATE is expected to notify CITY immediately upon discovery so necessary action can be taken to protect the public from any potential harm.

M. Payment/Fee Schedule

For the first year of this Agreement, SUNSHINE STATE agrees to pay the CITY \$62,745.00. Payments for all five years of this Agreement are based upon Schedule "A" which is set forth below. Payment shall be due monthly on the 20th day of each month. A current Bench Inventory and Shelter Inventory list shall be provided on the 1st day of each month, and the monthly payment will be based upon this inventory. Payment shall reflect the excess of bench revenues over shelter maintenance fees and be delivered to the City of Hollywood c/o the Director of Financial Services, Hollywood City Hall, 2600 Hollywood Boulevard, 1st Floor, Hollywood, FL 33022.
