AN ORDINANCE OF THE CITY OF HOLLYWOOD, FLORIDA, AMENDING ORDINANCE NO. O-2017-13, WHICH CREATED THE EMERALD HILLS SAFETY ENHANCEMENT DISTRICT; EXTENDING FOR SEVEN YEARS THE DATE ON WHICH THE DISTRICT WILL AUTOMATICALLY SUNSET UNLESS AGAIN EXTENDED; REQUIRING THE DISTRICT TO SUBMIT AN ANNUAL REPORT.

WHEREAS, Ordinance No. O-2017-13, which was passed and adopted on August 30, 2017, created the Emerald Hills Safety Enhancement District (the "District") effective immediately; and

WHEREAS, in Section 13, Ordinance No. O-2017-13 provides that Ordinance No. O-2017-13 shall automatically sunset three years from its effective date; and

WHEREAS, unless the City Commission takes action before August 30, 2020, Ordinance No. O-2017-13 will sunset on that date and the District will cease to exist; and

WHEREAS, the City Commission wishes to extend the life of the District for seven years; and

WHEREAS, the City Commission also wishes to require the District to submit an annual report to the Commission for review.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Ordinance.

Section 2: That Section 9 of Ordinance No. O-2017-13 is amended to read as follows:

Section 9: Applicable Financial Disclosure, Noticing, and Reporting Requirements. The District will provide all financial disclosures required by Florida law relating to dependent districts, including but not limited to, all financial disclosures relating to bonds, financing, non-ad valorem special assessments, and the like. Any and all meetings of the District Board shall be noticed in accordance with Chapter 286, Florida Statutes. Any and all notices that are required to be provided to landowners within the District shall be provided by U.S. Mail delivery or by posting public notice in a designated area within the District, which area shall be specified by the

District Board. The District will comply with all reporting requirements required by Florida law relating to dependent special districts. In addition, the District will prepare and submit to the City Commission for review an annual report on or about February 1 of each year, commencing in 2021.

Section 3: That Section 13 of Ordinance No. O-2017-13 is amended to read as follows:

Section 13. Sunset Provision. This Ordinance, as amended, shall automatically sunset on August 30, 2027 ~~three (3) years from the effective date hereof,~~ unless otherwise extended.

Section 4: That this ordinance shall be in full force and effect immediately upon its passage and adoption.
