A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO RENEW THE AGREEMENT WITH CIRCUIT TRANSIT INC., FORMALLY KNOWN AS THE FREE RIDE, FOR CIRCULATOR SERVICES UNDER THE SAME TERMS AND CONDITIONS IN AN ESTIMATED ANNUAL AMOUNT OF \$885,360.00.

WHEREAS, on October 17, 2018, City Commission passed and adopted Resolution No. R-2018-335, authorizing the execution of an agreement with Free Ride, now known as Circuit Transit Inc. ("Circuit"), for circulator services to and from Downtown Hollywood, Hollywood Beach, and the City's parking garages; and;

WHEREAS, the current agreement expired on March 4, 2020, but included the option to renew for three one year periods upon mutual agreement of the parties; and

WHEREAS, due to the current state of events relating to the COVID-19 virus, the City Manager, pursuant to Section 38.48(B) of the Purchasing Code, extended the current agreement for operational purposes for a period of 90 days, which brings the agreement date to June 4, 2020; and

WHEREAS, the parties desire to renew the existing agreement under the same terms and conditions for a one year period, which retroactively will commence on March 5, 2020 and expire on March 4, 2021; and

WHEREAS, on September 4, 2019, the Community Redevelopment Agency Board ("CRA") passed and adopted Resolution No. R-CRA-2019-38, approving and authorizing funding payments for cost sharing of the related transportation services; and

WHEREAS, Circuit continues to provide satisfactory services for circulator efforts to residents and tourists, as well as providing essential services during the COVID-19 pandemic; and

WHEREAS, as established in 2019, the circulator services are jointly funded by the CRA and the City; and

WHEREAS, funding for this effort will be distributed as follows: CRA will contribute 2/3rd of costs from account numbers 163.638504.55200.548060.000000.000.000 and 166.668602.55200.548060.000000.000.000, and the City will contribute the remaining 1/3 of the costs, which will be split between the Parking Fund in account number

446.150101.54500.531170.000000.000.000 and the Gas Tax Fund in account number 336.140201.54100.531170.000000.000; and

WHEREAS, the CRA will seek approval for its contribution amount through the CRA Board.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

<u>Section 2</u>: That it authorizes and approves the renewal of the Professional Services Contract for Circulator Services commencing on March 5, 2020 through March 4, 2021 with Circuit Transit Inc., under the same terms and conditions of the Agreement.

<u>Section 3</u>: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
