WHEREAS, there are two vacant citywide member positions due to the resignation of Tanya Krefsky, and the removal of Jacquelyn Noval hose terms expire June 30, 2021; and

WHEREAS, Grahm Rubin serves as an Alternate member and his term expires on June 30, 2020; and

WHEREAS, the City Clerk provided notice to the public that positions were available and solicited interest forms from citizens to fill the available vacancies; and

WHEREAS, the following individuals have expressed an interest in serving on the Sustainability Advisory Committee and are qualified to fill the vacancies:
