A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE AN AGREEMENT WITH TRANSMAP CORPORATION FOR A CITYWIDE PAVEMENT STUDY IN AN AMOUNT NOT TO EXCEED \$173,664.48.

WHEREAS, the Department of Development Services has determined that it is necessary to have a Citywide pavement study prepared to assist the City in planning a future resurfacing program and developing a capital / financial plan for such program purposes; and

WHEREAS, the Citywide pavement study is intended to include a pavement condition field survey of all the City's maintained streets and alleys; and

WHEREAS, the pavement study data collection will include an asset inventory of road and street-side features such as sidewalks, bike paths, swales, curb and gutter, pavement markings and signs, utility manholes and valves, street and light poles, trees, speed humps and on-street parking; and

WHEREAS, the last pavement study was completed in 2013, and updated data is necessary in order for the City to apply for Broward County Penny for Transportation Surtax funding for pavement rehabilitation and maintenance projects; and

WHEREAS, it is in the best interest of the City to utilize a civil engineering consulting firm that has the equipment, resources and experience to perform the survey; and

WHEREAS, on March 12, 2020, the 2020 City-Wide Pavement Study Project was electronically advertised in BidSync as Invitation for Bids Number IFB-4639-20-AP, and bid results were received on April 6, 2020 as listed below:

WHEREAS, the responses to IFB-4639-20-AP were reviewed by the Office of Procurement Services and it was determined that Transmap Corporation was the lowest responsive responsible bidder; and

WHEREAS, the Director of Development Services, the City Engineer and the Director of Procurement and Contract Compliance are recommending that the City Commission approve and authorize the appropriate City officials to execute an agreement with Transmap Corporation based upon the terms and conditions set forth in IFB-4639-20-AP for the development of the Citywide pavement study in an amount not to exceed \$173,664.48; and

WHEREAS, funding is available in account number 334.149901.51900.563010.001292.000.000.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

<u>Section 2</u>: That it approves and authorizes the execution, by the appropriate City officials, of an agreement with Transmap Corporation based upon the terms and conditions set forth in IFB-4639-20-AP, together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 3: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
