A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE AN AMENDMENT TO THE AGREEMENT WITH SUNSHINE AFTER SCHOOL CARE, INC. FOR THE 2020 SUMMER PROGRAM, REDUCING THE CURRENT PAYMENT RATE OF 25% TO 10% OF GROSS RECEIPTS; AUTHORIZING THE CITY MANAGER OR DESIGNEE TO NEGOTIATE A RATE REDUCTION OF PAYMENTS OF GROSS RECEIPTS FOR THE 2020 FALL PROGRAM.

WHEREAS, on April 20, 2016, through Resolution R-2016-114, the City authorized the execution of an agreement with Sunshine After School Child Care, Inc. ("Sunshine") for the operations of the City's Aftercare and Summer Camp Program Services at David Park Community Center and Driftwood Community Center; and

WHEREAS, the existing agreement between the City and Sunshine expires on June 9, 2021; and

WHEREAS, the novel coronavirus ("COVID-19") and the new requirements set forth by the Center for Disease Control, the State of Florida and Broward County limit facility capacities to operate a summer camp and aftercare program; and

WHEREAS, these new requirements and limits make it no longer fiscally feasible for Sunshine to operate under the current 25% gross receipt payments from summer camp revenue, and Sunshine is seeking to reduce the payment to the City to 10% of gross receipts; and

WHEREAS, the need for summer camp and after school care programs is vital to supporting the community returning to the work force; and

WHEREAS, for continuity of operations, site knowledge and experience, the Parks, Recreation and Cultural Arts Department is recommending execution of the amendment to the agreement with Sunshine; and

WHEREAS, in addition, the Parks, Recreation and Cultural Arts Department recommends authorizing the City Manager or designee to negotiate a rate reduction of future payments for the 2020 fall school aftercare program, with a minimum of no less than five percent and a maximum registration fee of \$250.00 per period in order to provide school aftercare program services.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes the execution by the appropriate City officials of the attached Amendment to the Agreement with Sunshine After School Care, Inc., for the summer 2020 program, reducing the payment rate from 25% to 10% of gross receipts, together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 3: That it authorizes the City Manager or designee to negotiate rate reduction of payments of gross receipts with a minimum of no less than 5% and a maximum registration fee of \$250.00 for the fall 2020 school aftercare program.

Section 4: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
