A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING THE FINAL DESIGN OF AN OCEAN-THEMED MURAL TO BE INSTALLED ON THE WALL NORTH OF SHERIDAN STREET, EAST OF I-95 IN FLORIDA DEPARTMENT OF TRANSPORTATION RIGHT-OF-WAY (A/K/A BRUCE TERRACE MURAL); AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ENTER INTO A COMMUNITY AESTHETIC FEATURE AGREEMENT WITH THE FLORIDA DEPARTMENT OF TRANSPORTATION FOR INSTALLATION AND MAINTENANCE OF THE MURAL.

WHEREAS, on April 20, 2016, several community members from the Bruce Terrace neighborhood requested the City Commission's assistance to install a mural along the Florida Department of Transportation ("FDOT") wall just east of I-95, north of Sheridan Street; and

WHEREAS, on November 2, 2016 Resolution R-2016-318 supported the community's efforts by approving the ocean-themed mural concept, supporting efforts to raise funds and authorized the establishment of appropriate City funding accounts to do so; and

WHEREAS, R-2016-318 also required final City Commission approval of the mural's design and the attached Community Aesthetic Feature Agreement ("CAFA"), once all the funds were secured; and

WHEREAS, City staff and the community have continued to pursue these efforts to install a mural, and as result, the CAFA was inadvertently and prematurely executed by City staff; and

WHEREAS, the community has currently raised funding in the amount of \$8,220.65 to install the mural in accordance with FDOT's CAFA requirements, including but not limited to removal and restoration of the wall by securing and submitting to FDOT a \$3,000.00 "removal and restoration deposit"; and

WHEREAS, through an appropriate competitive procurement process, an artist has been selected to install the mural; and

WHEREAS, funding for installation and future removal of the mural is available in account number 001.000000.22000.220523.000000.000.000.

THE FINAL DESIGN OF AN OCEAN-THEMED MURAL TO BE INSTALLED ON THE WALL NORTH OF SHERIDAN STREET, EAST OF I-95 IN FLORIDA DEPARTMENT OF TRANSPORTATION RIGHT-OF-WAY; AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ENTER INTO A COMMUNITY AESTHETIC FEATURE AGREEMENT WITH FDOT FOR INSTALLATION AND MAINTENANCE OF THE MURAL.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves the ocean-themed mural and approves and authorizes the execution of the attached CAFA, together with such non-material changes as may be acceptable to the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 3: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
