Fixed awning frames, fabricated by us, are certified by an engineer to comply with the latest building code release. The framework is designed to withstand winds in excess of 174 miles per hour with the cover removed. With the cover on, it is certified to take sustained winds of up to 75miles per hour and up to 120 mile per hour three second gusts. After nearly 40 years in business we can proudly say that our frames are built to last for decades.

## Framing Product for Fixed Awnings

- Frame will be manufactured with Gatorshield steel; a very durable, American made steel that weighs approximately 32% less than schedule 40 steel out of China and has about 4 times the inherent corrosion resistance.
- All metal will be 50/55 Gatorshield by Allied Tubing unless otherwise specified. This
  cold rolled tubing is zinc coated (galvanized) on both the inside and outside walls with
  99.99% pure zinc making the galvanizing layer virtually lead-free. There is also a
  conversion coating and a clear polymer top coat to further assist the zinc with corrosion
  inhibition.
- All structural pipe 1.75"round and legs 3" SQUARE
- All framing members to be joined by mig welding (wire feed) by a certified welder.
- Each framing member and all pipe ends are to be mitered or coped appropriately to provide a tight clean fit.
- Welds that interface with the vinyl shall be ground smooth and deburred.
- Each framing member will be primed with a zinc and epoxy based primer at the junctions (in effect, re-galvanizing the welds) and have an even coat of paint over the entire frame.
- No smashed pipe ends or open pipe ends allowed.
- Frame will be sprayed with Sherwin Williams electrostatic paint in a (choice) color.

- Vinyl fabric will be used 18 oz. with a UV top coat.
- Vinyl will be installed tight and free of wrinkles, sagging, or puckers. All panels will be equal intension and quality.
- Vinyl will be installed with a lace on process in which the awning is attached with a nylon rope assembly through brass grommets around the tubular construction.
- All sewing connections will have a color coordinated stitching warranty is available with an upgrade to Tenara thread.
- We will also give you the Fire Certification cards for the fire marshal.
- All sewn seams will be sewn with a U V 132 thread system.
- Curtain will be made of fine mess screen it will stop the rain and still breath.
- All fabric or vinyl products shall be warranted for a period of five (5) years from the date of installation, provided covers are removed as required by the Florida Building Code in the unlikely event of a hurricane.
- Warranty covers excessive fading, cracking, or discoloration.
