

RESOLUTION NO. R-BCRA-2020-13

A RESOLUTION OF THE HOLLYWOOD, FLORIDA  
COMMUNITY REDEVELOPMENT AGENCY ("CRA"),  
AMENDING THE ANNUAL BUDGET FOR THE BEACH  
DISTRICT OF THE CRA FOR FISCAL YEAR 2020;  
REVISING EXPENDITURES.

WHEREAS, on September 26, 2019, pursuant to Resolution No. R-BCRA-2019-45, the Community Redevelopment Agency ("CRA") adopted a Budget for Fiscal Year 2020 for the Beach District of the CRA; and

WHEREAS, Resolution R-BCRA-2019-45 specifically set forth that the Budget may be amended when final information is available and as may be otherwise advisable from time to time during the fiscal year; and

WHEREAS, on November 20, 2018, pursuant to Resolution No. R-BCRA-2019-64, the CRA amended the FY 2020 annual budget for the Beach District; and

WHEREAS, certain routine and periodic budgetary adjustments and transfers are appropriate; and

WHEREAS, since the adoption and subsequent amendment of the FY 2020 budget for the Beach District, it is necessary to amend the annual budgeted expenditures, as more specifically described in the attached Exhibit "A".

NOW, THEREFORE, BE IT RESOLVED BY THE HOLLYWOOD, FLORIDA  
COMMUNITY REDEVELOPMENT AGENCY:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and adopts the attached Fiscal Year 2020 Amended Budget as more specifically set forth in Exhibit "A" for the Beach District of the CRA.

Section 3: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
