WHEREAS, the City desires to protect its assets through the purchase of various insurance products; and

WHEREAS, in accordance with Section 38.41(C)(10) of the City's Purchasing Ordinance, purchases of insurance through the City's "Agent of Record" are exempt from the competitive bid and competitive proposal requirements; and

WHEREAS, on May 15, 2019, through RFP 4606-19-AP and Resolution R-2019-116, the City designated Aon Risk Services, Inc. of Florida ("Aon") as its Agent of Record; and

WHEREAS, the flood insurance policies are for the October 2020 renewal period and are the same as expiring policies, with a 4% premium increase; and

WHEREAS, funding for this service will be available in the Fiscal Year 2021 budget in account number 558.112006.51900.591940.000000.000.000 subject to approval and adoption by the City Commission.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA.

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

<u>Section 2</u>: That it approves and authorizes the binding, by the appropriate City officials, for renewal policies with Hartford Fire Insurance Company for flood insurance policies for a not to exceed amount of \$58,601.00, in a form acceptable to the City Manager and approved as to form and legal sufficiency by the City Attorney.
