A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING AND APPROVING THE APPROPRIATE CITY OFFICIALS TO ISSUE PURCHASE ORDER TO А MUNICIPAL EQUIPMENT COMPANY, LLC FOR THE PURCHASE OF A SECOND SET OF BUNKER GEAR FOR FIRE RESCUE AND BEACH SAFETY PERSONNEL IN THE TOTAL AMOUNT OF \$504,000.00 BASED UPON THE LAKE COUNTY CONTRACT COOPERATIVE BID SOLICITATION NO. 17-0606H IN ACCORDANCE WITH SECTION 38.41(C)(5) OF THE PURCHASING ORDINANCE (PIGGYBACK).

WHEREAS, the Fire Rescue and Beach Safety Department requires a second set of bunker gear for firefighters to reduce exposures to carcinogens and toxins on the fire scene; and

WHEREAS, the second set of bunker gear being requested is a Lion: Janesville V-Force coat and pants with suspenders; and

WHEREAS, the Lake County Contract approved and authorized the award of Bid Number 17-0606H for Fire Equipment Parts-Supplies-Service, which was competitively bid and effective July 1, 2017 through June 30, 2021; and

WHEREAS, Municipal Equipment Company, LLC has agreed to provide Lion: Janesville V-Force coat and pants with suspenders for the amount of \$504,000.00; and

WHEREAS, Section 38.41 (C)(5) of the Purchasing Ordinance allows the Director to procure, without following formal procedures, all goods and services that are subject of contracts with the state, its political subdivisions, the United States government, other governmental entities, or a corporation not for profit whose members are governmental entities, public officers, or any combination thereof, provided that the goods and services are (i) the subject of a price schedule negotiated by the state or the United States government, or (ii) the subject of a contract with another governmental entity or a corporation not for profit whose members are governmental entities, public officers, or any contract with another governmental entity or a corporation not for profit whose members are governmental entities, public officers, or any combination thereof, which contract is based strictly on competitive bids or competitive proposals and not on any preference; and

WHEREAS, the Fire Chief and the Director of Procurement and Contract Compliance recommend that the City Commission approve the issuance of a purchase order to Municipal Equipment Company, LLC for Lion: Janesville V-Force coat and pants with suspenders for a total amount of \$504,000.00; and WHEREAS, funding has been provided via Resolution No. R-2020-XXX, which continued the appropriation for previously approved capital projects from FY 2020 to FY 2021; and
