A RESOLUTION OF THE CITY COMMISSION OF THE CITY **AUTHORIZING** OF HOLLYWOOD. FLORIDA, **OFFICIALS** EXECUTE APPROPRIATE CITY TO OF UNDERSTANDING MEMORANDUM WITH THF AMERICAN FEDERATION OF STATE, COUNTY AND LOCAL MUNICIPAL EMPLOYEES. 2432. **GENERAL** EMPLOYEES BARGAINING UNIT, AMENDING THE TERMS OF THE COLLECTIVE BARGAINING AGREEMENT WITH CHANGES TO THE WAGES ARTICLE TO REFLECT A 2% INCREASE TO THE PAY RANGES AND A 2% WAGE INCREASE FOR ALL BARGAINING UNIT MEMBERS.

WHEREAS, the City and the American Federation Of State, County And Municipal Employees, Local 2432 ("AFSCME"), are parties to a Collective Bargaining Agreement ("CBA") from the period of October 1, 2018 through September 30, 2020, covering the City's general employees; and

WHEREAS, the City and AFSCME are in the process of negotiating a successor CBA; and

WHEREAS, the parties desire to address Article 10 (Wages) prior to the conclusion of a negotiated successor agreement and not to be delayed by the ongoing COVID19 pandemic; and

WHEREAS, the parties have negotiated the attached MOU containing changes to Article 10 (Wages), providing that effective October 1, 2020, the pay ranges within the Bargaining Unit shall be increased by two percent (2%) and employees whose base pay is below the top of the new pay range shall receive a two percent (2%) wage increase to their base pay effective the first full pay period after September 30, 2020; and

WHEREAS, the MOU shall become effective as of the date of ratification by both parties.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA.
