Goals for the upcoming year:

Property improvement Grants

- Continue our commitment to improve the appearance of our corridors and neighborhood street systems
- Continue planning and implementation of Downtown neighborhood enhancement and other improvements to increase walk-ability and connectivity of neighborhoods to the Downtown Core
- Continue to coordinate with Developers and City Staff to ensure timely review and issuance
 of permits for all quality development and redevelopment projects located in the CRA
 Districts with a major focus on the Block 57 and Block 58 projects

- Implement CIP improvements as prioritized and funded by CRA Board with a particular focus on completing all identified projects within the time span required for the CRA:
 - A1A Complete Streets north of Hollywood Blvd. to Sheridan Street
 - Planning and implementation of Phase IV and A1A undergrounding project South of Hollywood Blvd
 - Hollywood Blvd redesign and construction within the Downtown core
- Continue to provide a greater focus on economic development for the CRA districts, working with property owners and brokers to secure viable tenants to fill up current vacancies
- Coordinate Marketing and Communication programs to achieve maximum benefit for CRA and City of Hollywood
- Continue to provide regular monthly reports to CRA Board regarding staff activities
- Continue our commitment to raise the bar on property standards for both public and private properties
- Coordinate with City Code Compliance Staff to continue our commitment to strengthen our code compliance system to serve as a strong deterrent
- Continue to improve lines of communication with City staff and stakeholders in our community including:
 - Standing meetings with City Manager
 - Continue close coordination with City Staff on all CRA activities
 - Attending and participating in regular City Manager Staff meetings
 - Speaking at a variety of neighborhood and community organization meetings
 - Participating at State and National conferences such as International Downtown Association, Florida Redevelopment Association and Urban Land Institute
