# Hollywood Beach

Board member Blattner stated that all concerns related to the reopening of Hollywood Beach must be taken into consideration and the outcome of our neighboring beach.

## **Adam Street**

Board member Blattner advised that the Adam Street project need to be approached in a long term project with more input and planning.

# Fourth of July Holiday

Board member Blattner stated that the fourth of July holiday is upcoming and requested that staff start planning for this event with the pandemic.

#### COVID 19

Board member Biederman stated that the Memorial Day weekend and the Fourth of July Event will be canceled due to the pandemic. He encouraged everyone to stay safe and healthy. He further thanked everyone who participated in the community food give away.

### COVID 19

Board member Sherwood stated that we are not out of the woods with COVID-19 and encourage businesses and patrons to follow the guidelines recommended by the Public Health Officials.

### Beach and Downtown Budgets

Board member Sherwood requested that staff review the upcoming budgets and reassess projects timeline. She asked that staff focus on the projects that can be done now oppose to what can be done later.

### COVID-19

Businesses will have to enforce the CDC requirements such as social distancing and crowd control. Chair Levy then thanked all staff for their effort during the pandemic and further stated that as soon as the Public Health Officials tell us it is safe, Hollywood will reopen.
