A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO CERTIFY AND FILE A RIGHT-OF-WAY MAINTENANCE MAP DEDICATING AND VESTING ALL RIGHTS, TITLE, EASEMENT AND APPURTENANCES OF THAT PORTION OF THE CONSTRUCTED WASHINGTON STREET WITHIN THE CITY PURSUANT TO SECTION 95.361(3), FLORIDA STATUTES.

WHEREAS, a portion of Washington Street (the "Road") described in the Right of Way Maintenance Map, attached as Exhibit "A" (the "Maintenance Map"), is shown by historic aerials to have been in existence since at least 1963; and

WHEREAS, a search of the public records of Broward County, Florida, has not produced any document formally conveying or dedicating the road, or a right-of-way easement for the road, to the City of Hollywood or any other governmental entity; and

WHEREAS, the road is located within the municipal limits of the City of Hollywood and the City has regularly maintained and repaired the road for more than the immediate past seven years; and

WHEREAS, Section 95.361(2), Florida Statutes, provides that when a road has been regularly maintained for the immediate past seven years by a municipality, such road shall be deemed to be dedicated to the public, and the dedication shall vest all rights, title, easement and appurtenances in and to the road in the municipality; and

WHEREAS, Section 95.361(3), Florida Statutes, provides that the filing of a map duly certified by the Mayor and the City Clerk of the municipality in the Office of the Clerk of the Circuit Court of the county where the road is located showing the lands and reciting on the map that the road has vested in a municipality in accordance with Section 95.361(2), F.S., shall be prima facie evidence of ownership of the land by the municipality; and

WHEREAS, the attached Maintenance Map complies with the requirements of Section 95.361(3), Florida Statutes.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO CERTIFY AND FILE A RIGHT-OF-WAY MAINTENANCE MAP DEDICATING AND VESTING ALL RIGHTS, TITLE, EASEMENT AND APPURTENANCES OF THAT PORTION OF THE CONSTRUCTED WASHINGTON STREET WITHIN THE CITY PURSUANT TO SECTION 95.361(3), FLORIDA STATUTES.

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

<u>Section 2</u>: That it authorizes the appropriate City officials to certify and file the attached Exhibit "A" right-of-way Maintenance Map as provided in Section 95.361(3), Florida Statutes.

<u>Section 3</u>: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
