WHEREAS, the CRA Board desires to cancel the regularly scheduled Wednesday, January 5, 2022 CRA Board meeting; and

WHEREAS, the CRA Board desires to add citizens comments at 9:00 A.M. on the regularly scheduled Wednesday, January 19, 2022 meeting due to cancelling the January 5, 2022 CRA Board meeting.

NOW, THEREFORE, BE IT RESOLVED BY THE HOLLYWOOD, FLORIDA COMMUNITY REDEVELOPMENT AGENCY:

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

<u>Section 4</u>: That the regular meeting of the CRA Board scheduled on December 15, 2021 shall be canceled.

<u>Section 5</u>: That the regular meeting of the CRA Board scheduled on January 5, 2022 shall be canceled.

<u>Section 6</u>: That the regular meeting of the CRA Board scheduled on January 19, 2022 shall have citizens' comments at 9:00 A.M.

<u>Section 7</u>: Thereafter, regular meetings of the CRA Board shall, unless otherwise provided by Resolution, be held on the first and third Wednesdays of each month.

<u>Section 8</u>: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
