When Lacy and Ida McCumber moved to a house across the street from a City owned public golf course designed by Donald Ross in Jacksonville, Florida, little did they know how it would shape the careers of their four sons. McCumber Golf began as a small landscape design and golf consulting firm in 1971, and by the late 1970's had designed, developed and constructed the award-winning Ravines Golf Resort in Middleburg, Florida. Throughout the early 1980's McCumber Golf constructed courses for other architects as it simultaneously built a reputation as a top quality golf course design company. By the late 80's the design arm, Mark McCumber & Associates, was firmly established and from that point on McCumber Golf constructed its own designs exclusively.

Over the course of these years Mark McCumber earned his PGA TOUR card and his first win at the Doral Blue Monster (1979). He went on to win 10-times on the PGA TOUR, including the 1988 Players Championship at the TPC Stadium Course and the 1994 Tour Championship at the Olympic Club in San Francisco. He represented the United States in the 1989 Ryder Cup Matches and also won the World Cup with Ben Crenshaw in 1988. Mark's presence on the PGA TOUR and his past experience as a Landscape Designer propelled McCumber Golf into involvement with notable projects, including Osprey Cove in St. Marys, Georgia, a remodel of the West Palm Beach Golf Course (Runner-up Golf Inc. 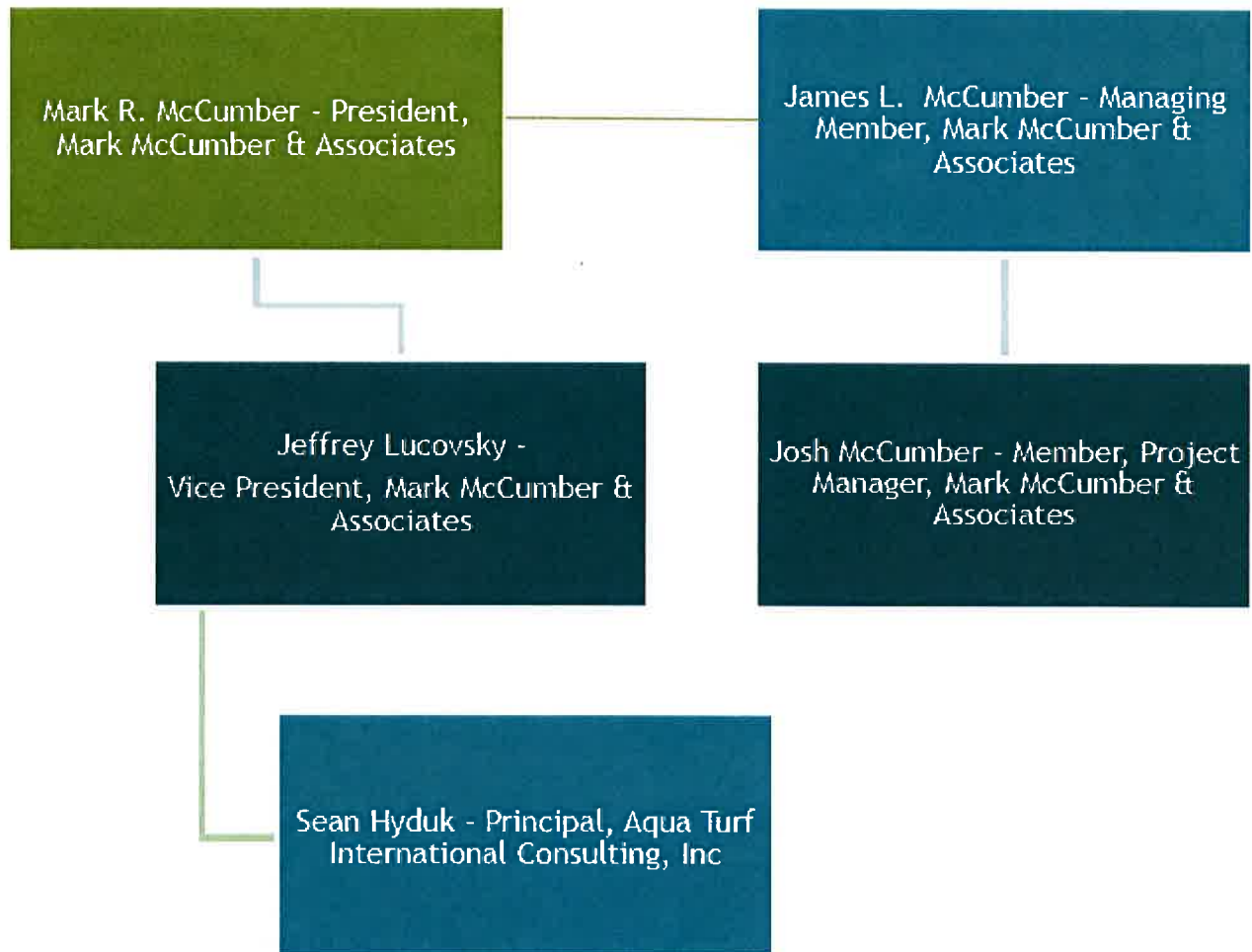

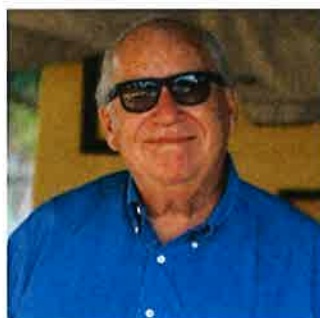

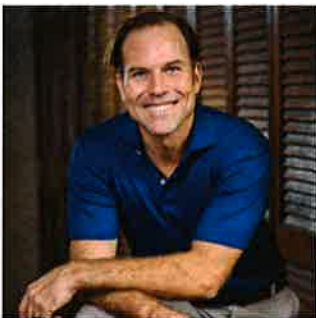

Evaluation Criterion #3: Approach to Scope of Work (4.2.5)

Mark McCumber & Associates has been involved with the Hollywood Beach Golf Course since 2013. We are the design arm of McCumber-Wright Venture, LLC. The Mark McCumber & Associates team has a strong relationship with the City of Hollywood and understands the City's approval process.

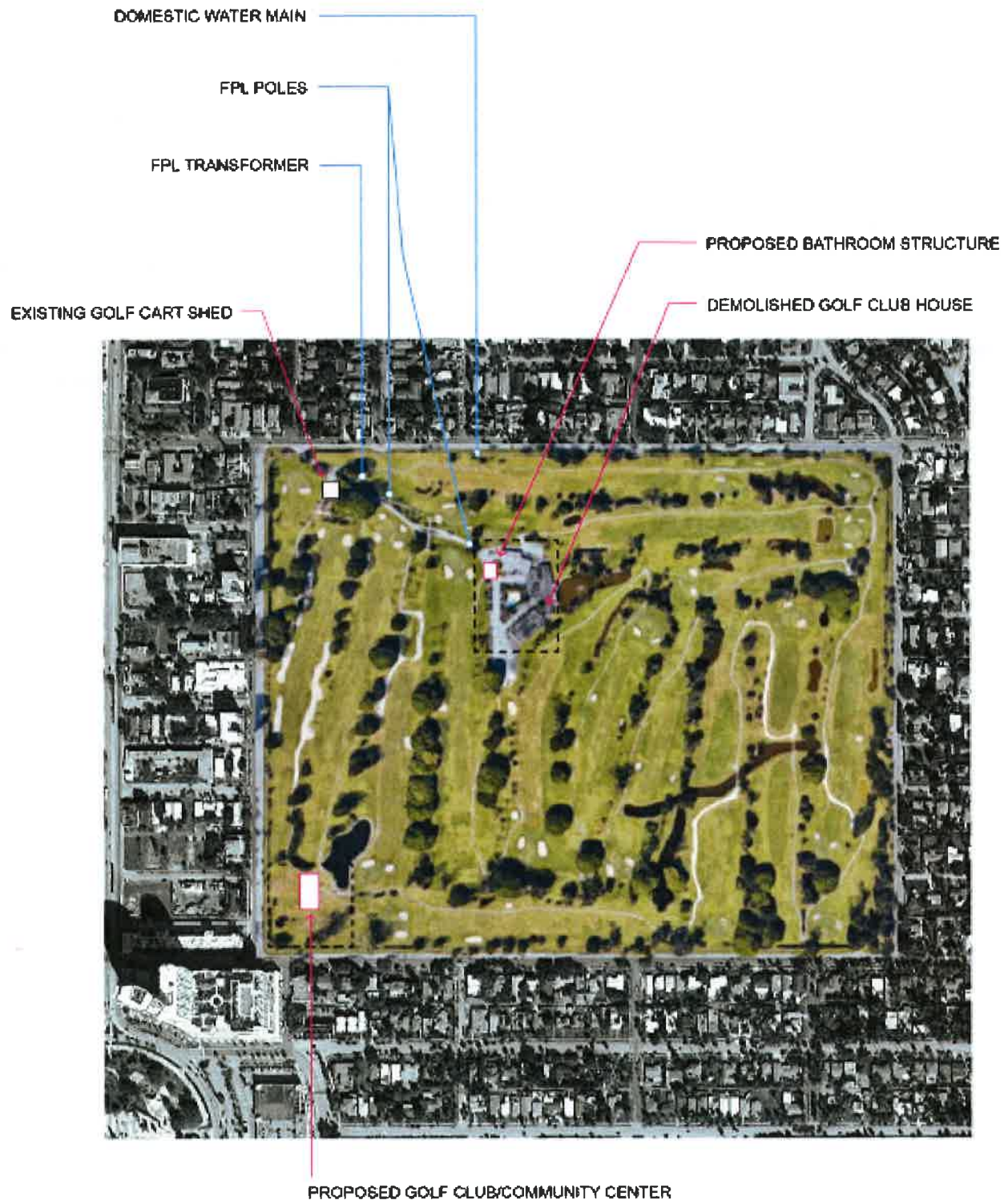

Mark McCumber & Associates is proposing to provide a 'linear park' around the perimeter of the project site to act as a buffer between the neighboring homes but more importantly, to create a 'community nature center' that will teach children and adults about the native vegetation and micro-eco systems.

The design will meet all of the design criteria set forth in the City ordinances in addition to the Design Review Criteria that includes Architectural and Design Components, Compatibility, Scale/Massing, and Landscaping.

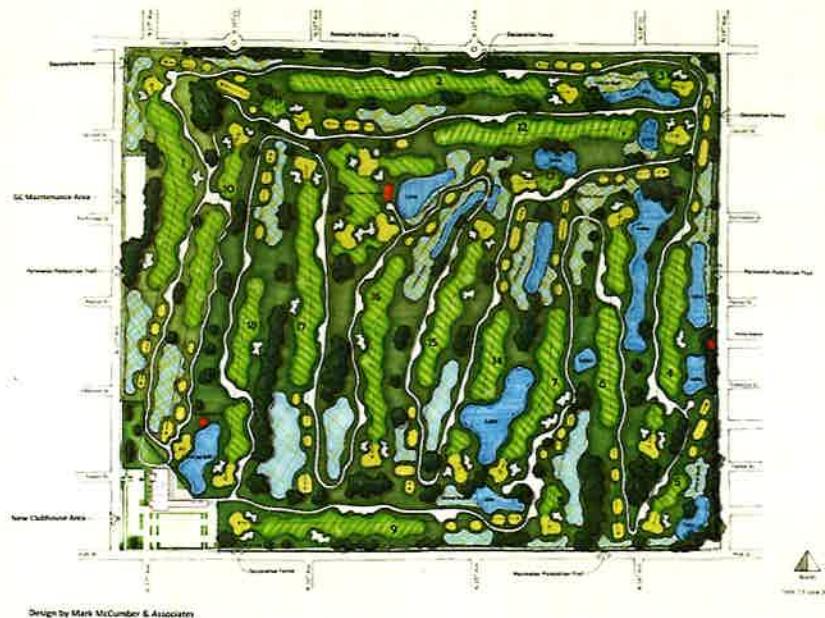

Project Methodology
