A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, CONSIDERING THE CONTINUANCE/SUNSETTING OF THE FOLLOWING ADVISORY BOARDS: AFFORDABLE HOUSING ADVISORY COMMITTEE; AFRICAN AMERICAN ADVISORY COUNCIL; ARTWORK SELECTION ADVISORY COMMITTEE; EDUCATION ADVISORY COMMITTEE; GENERAL OBLIGATION BOND OVERSIGHT ADVISORY COMMITTEE; MARINE ADVISORY BOARD; NEIGHBORHOOD WATCH ADVISORY BOARD; PARKS, RECREATION & CULTURAL ARTS ADVISORY BOARD; SUSTAINABILITY ADVISORY COMMITTEE AND THE YOUNG CIRCLE ARTSPARK ADVISORY BOARD.

WHEREAS, Section 37.25 of the Code of Ordinances sets forth the uniform regulations relating to City Advisory Boards, including the sunseting and/or continuance of such boards; and

WHEREAS, pursuant to R-2020-054, the City Commission by majority vote continued the following Advisory Boards: Affordable Housing Advisory Committee, African American Advisory Council, Artwork Selection Advisory Committee, Education Advisory Committee, Marine Advisory Board, Neighborhood Watch Advisory Board; Parks, Recreation & Cultural Arts Advisory Board; Sustainability Advisory Committee, and the Young Circle ArtsPark Advisory Board; and

WHEREAS, the General Obligation Bond Oversight Advisory Committee has been in existence for more than one year, and must be considered for continuance along with the above referenced advisory boards; and

WHEREAS, the above referenced Advisory Boards are scheduled to be sunsetted and therefore must be considered by the City Commission at its March 3, 2021 meeting in order for the City Commission to determine whether to sunset the boards or by a majority vote continue the operation of the boards.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA.

Section 1: The foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: The City Commission approves the continuance or sunseting of the following Advisory Boards as of this date:
