A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ISSUE A PURCHASE ORDER TO DUVAL FLEET FOR THE PURCHASE OF TWO VEHICLES IN THE AMOUNT OF \$127,908.00 AND TO ISSUE A PURCHASE ORDER TO PALMETTO FORD TRUCK SALES, INC. FOR THE PURCHASE OF THREE VEHICLES IN THE AMOUNT OF \$328,629.00 BASED UPON THE FLORIDA SHERIFF ASSOCIATION CONTRACT BID AWARD NO. FSA20-VEH18.0, IN ACCORDANCE WITH SECTION 38.41(C)(5) OF THE CITY'S PROCUREMENT CODE. (PIGGYBACK)

WHEREAS, the Department of Public Works, Fleet Management Division, on behalf of the Department of Public Utilities and the Department of Public Works, requires the purchase of five new vehicles to replace vehicles that have reached or surpassed their life expectancy and road worthiness by age, mileage and wear, and can no longer be relied upon to perform at required operational levels; and

WHEREAS, the Public Works Department is requesting the purchase of two new vehicles: one 2021 Chevrolet Silverado 5500HD Crew Cab 2YD. Dump Body Truck WT, DRW (CC56043/C5B), Specification #17, and one 2021 Chevrolet Silverado 5500HD Crew Cab Stake Body Truck WT, DRW (CC56043), Specification #17; and

WHEREAS, the Department of Public Utilities is requesting the purchase of three new 2022 Ford F-550 4x2 Trucks with Crane Body and 7,500 lb. Crane, Specification #37 (F5G); and

WHEREAS, the requested vehicles were competitively bid through the Florida Sheriff Association Bid Number FSA20-VEH18.0, for a term effective October 1, 2020 through September 30, 2022, for the use and reliance of government entities within the State of Florida; and

WHEREAS, award was made to Duval Fleet and Palmetto Ford Truck Sales, Inc. as the lowest and best responsive bidders by specification, manufacturer and by zone; and

WHEREAS, Duval Fleet has agreed to provide to the City, under the exact pricing, terms and conditions set forth in the FSA Bid the following vehicles: one new 2021 Chevrolet Silverado 5500HD Crew Cab 2YD Dump Body Truck WT, DRW (CC56043/C5B), Specification #17, and one new 2021 Chevrolet Silverado 5500HD Crew Cab Stake Body Truck WT, DRW (CC56043), Specification #17; and

WHEREAS, Palmetto Ford Truck Sales, Inc. has agreed to provide the City, under the exact terms and conditions set forth in the FSA Bid, the following vehicles: three new 2022 Ford F-550 4x2 Truck with Crane Body and 7,500 lb. Crane, Specification #37 (F5G); and

WHEREAS, Section 38.41(C)(5) of the City's Procurement Code allows the Chief Procurement Officer to procure, without formal solicitation procedures, all goods, supplies, materials, equipment, and services that are the subject of contracts with the State, its political subdivisions, the United States government, other governmental entities, or a corporation not for profit whose members are governmental entities, public officers, or any combination thereof ("piggyback"), provided that the goods, supplies, materials, equipment, or services are the subject of a price schedule negotiated by the entities listed above and is based strictly on competitive bids, quotations, or competitive proposals and not on any preference and such utilization of other governmental entities contracts shall be permitted only during the term of the other governmental entity's contract; and

WHEREAS, the Director of Public Works and the Assistant Director of Financial Services for Procurement recommend that the City Commission approve and authorize the issuance of the attached Purchase Order to Duval Fleet in the amount of \$127,908.00; and

WHEREAS, the Director of Public Works and the Assistant Director of Financial Services for Procurement recommend that the City Commission approve and authorize the issuance of the attached Purchase Order to Palmetto Ford Truck Sales, Inc. in the amount of \$328,629.00; and

WHEREAS, funding for these purchases has been appropriated and exists in account numbers 557.519901.51900.564520.000120.000.000, 336.509901.541.564530.000000.000.000 and 557.519901.51900.564520.000122.000.000.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes the issuance, by the appropriate City officials, of the attached Purchase Order to Duval Fleet, together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 4: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
