A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ISSUE A PURCHASE ORDER TO ALAN JAY AUTOMOTIVE MANAGEMENT INC., D/B/A ALAN JAY FLEET SALES, FOR THE PURCHASE OF FOUR VEHICLES IN THE AMOUNT OF \$106,921.00 AND AUTHORIZING THE ISSUANCE OF A PURCHASE ORDER TO ALAN JAY CHEVROLET FOR THE PURCHASE OF 12 VEHICLES IN THE AMOUNT OF \$392,392.00 BASED UPON THE SOURCEWELL (FORMALLY KNOWN AS NJPA) CONTRACT NUMBER 2020-120716 NAF IN ACCORDANCE WITH SECTION 38.41(C)(5) OF THE CITY'S PROCUREMENT CODE. (PIGGYBACK)

WHEREAS, the Department of Public Works, Fleet Management Division, on behalf of the various departments, requires the purchase of 16 new vehicles to replace a portion of those vehicles that have reached or surpassed their life expectancy and road worthiness by age, mileage and wear, and can no longer be relied upon to perform at required operational levels; and

WHEREAS, the Department of Public Utilities is requesting the purchase of nine vehicles: one 2022 Chevrolet Silverado 2500 Utility Body Truck 2WD (CC20903 1WT); six 2022 Chevrolet Silverado 2500 Pickup Trucks 2WD (CC20903 1WT); one 2021 Ford Transit T250 Cargo Van RWD (R1C), and one 2021 Ford Transit Connect XL SWB Cargo Van (S6E); and

WHEREAS, the Parks and Recreation Department is requesting the purchase of three 2022 Chevrolet Silverado 2500 Pickup Trucks 2WD (CC20903 1WT); and

WHEREAS, the Information and Technology Department is requesting the purchase of one 2021 Ford Transit Connect XL SWB Cargo Van (S6E); and

WHEREAS, the Department of Public Works is requesting the purchase of three vehicles: one 2022 Chevrolet Silverado 2500 Utility Body Truck 2WD (CC20903 1WT); one 2022 Chevrolet Silverado 2500 Pickup Truck 2WD (CC20903 1WT), and one 2021 Ford Transit Connect XL SWB Cargo Van (S6E); and

WHEREAS, the requested vehicles were competitively bid through the Sourcewell Contract (formerly known as NJPA) pursuant to Bid Numbers #2021-120716 NAF for a term effective January 17, 2021 through January 17, 2022 for the use and reliance of government entities within the State of Florida; and

WHEREAS, award was made to Alan Jay Automotive Management Inc., d/b/a Alan Jay Fleet Sales, and Alan Jay Chevrolet as the lowest and best responsive bidders by specification, manufacturer and by zone; and

WHEREAS, Alan Jay Automotive Management Inc. has agreed to provide to the City, under the exact pricing, terms and conditions of the Sourcewell Bid, one new 2021 Ford Transit T250 Cargo Van RWD (R1C) and three new 2021 Ford Transit Connect XL SWB Cargo Vans (S6E), in the amount of \$106,921.00; and

WHEREAS, Alan Jay Chevrolet has agreed to provide to the City, under the exact pricing, terms and conditions of the Sourcewell Bid, two new 2022 Chevrolet Silverado 2500 Utility Body Trucks 2WD (CC20903 1WT), and ten new 2022 Chevrolet Silverado 2500 Pickup Trucks 2WD (CC20903 1WT), in the amount of \$392,392.00; and

WHEREAS, Section 38.41(C)(5) of the City's Procurement Code allows the Chief Procurement Officer to procure, without formal solicitation procedures, all goods, supplies, materials, equipment, and services that are the subject of contracts with the State, its political subdivisions, the United States government, other governmental entities, or a corporation not for profit whose members are governmental entities, public officers, or any combination thereof ("piggyback"), provided that the goods, supplies, materials, equipment, or services are the subject of a price schedule negotiated by the entities listed above and is based strictly on competitive bids, quotations, or competitive proposals and not on any preference and such utilization of other governmental entities contracts shall be permitted only during the term of the other governmental entity's contract; and

WHEREAS, the Director of Public Works and the Assistant Director of Financial Services for Procurement recommend that the City Commission approve and authorize the issuance of the attached Purchase Order to Alan Jay Automotive Management Inc., d/b/a Alan Jay Fleet Sales, for the purchase of four vehicles in the amount of \$106,921.00; and

WHEREAS, the Director of Public Works and the Assistant Director of Financial Services recommend that the City Commission approve and authorize the issuance of the attached Purchase Order to Alan Jay Chevrolet for the purchase of 12 vehicles in the amount of \$392,392.00; and

WHEREAS, funding for the purchase has been appropriated and exists in account numbers 557.519901.51900.564520.000122.000.000, and
557.519901.51900.564520.000120.000.000,
557.519901.51900.564520.000117.000.000.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes the issuance, by the appropriate City officials, of the attached Purchase Order to Alan Jay Automotive Management Inc., d/b/a Alan Jay Fleet Sales, together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 3: That it approves and authorizes the issuance, by the appropriate City officials, of the attached Purchase Order to Alan Jay Chevrolet, together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 4: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
