**Organization's Background:** Please provide a concise description of the Applicant Agency, including its history, years of operation, general mission statement, and primary services provided.

The mission of the Art and Culture Center/Hollywood is to cultivate creativity and the support of the arts in our community through education, innovation and collaboration.

The Center was founded in 1975 and incorporated on August 31, 1978, as the only visual arts non-profit organization in south Broward County, operating out of a small community space on Hollywood beach. The Center now manages visual arts galleries in the renovated Kagey Home built in 1924, an Arts School that is adjacent to the main facility, and a 500-seat theater in downtown Hollywood. It is one of South Florida's leading multi-disciplinary arts organizations and impacts, on average, more than 45,000 people each year through its programs and venues. The Center is the third oldest arts non-profit in Broward County, and was designated a Major Cultural Institution by the Broward County Commission on Oct. 6, 2005. In 2015, the Center was selected as 2-1-1 Broward's "Non-Profit Organization of the Year – Arts" at the Fifth Annual Non-Profit Academy Awards.

The Center is a regional leader among South Florida arts institutions in presenting standards-based arts education for youth, and contemporary visual arts exhibitions by national and local artists. Instruction for youth links curricula to other core subjects such as math, science, literacy, and cultural studies. This shows students how the arts may inform all facets of learning. Each year, approximately 4,000 youth experience the arts in more than 140 unique curriculum sessions or classes, or as attendees to a Center performance or exhibition. In 2016, ACCH received an ArtsEd Forever! award from the Broward Cultural Division for Exceptional Service & Outstanding Contributions to Arts Education in Broward County. Programs include Summer Arts Camp, Arts Aspire, Free Arts! Family Days, Distance Learning Arts Studio, Center Stage Kids, ARTastic Collaborations, Private ad Group Lessons, and Community Gallery exhibitions. Since 2011, a total of 2,082 children ages 4-17 – about 225+ per summer – have enrolled in a visual and/or performing arts session at Summer Arts Camp. In 2019, the Center debuted the Early Voices Collaborative Exhibition, which resulted in original artworks created by more than 400 pre-K children enrolled in 17 early-learning centers in Broward County.

The Center presents up to 12 contemporary gallery exhibitions annually that showcase original works by more than 150 local and national artists. Exhibitions include the monthly Free Arts! Family Days, which provides free admission and a STEAM-Themed art-making activity on the third Sunday of every month. Exhibitions attract audiences from throughout South Florida and visitors to our region, raising awareness of Hollywood as a leading arts destination while providing economic benefits to City businesses.

### PROGRAM INFORMATION

1. How does your proposed project address the LETF Category (see above) as well as the Hollywood Police Department's Priority Area?

The Arts Access Leadership and Scholarship Program will provide youth from all economic backgrounds in Hollywood with intensive development opportunities in FY22 through two arts-education initiatives – the Arts Aspire leadership program (Oct. 2021 to Aug. 2022) and reduced-tuition scholarships for students ages 4-18 to enroll in the 2022 Summer Arts Camp (June-Aug. 2022). Arts Access provides youth with focused and collaborative activities that are presented in a safe, nurturing environment outside of school sites, assuring continued academic and personal growth in after-school and summer-break settings. In a study published by the American Psychological Association in 2020, researchers found, "Children with stronger school readiness skills at age 4 and stronger academics in 5th grade were more likely to enroll in arts-related courses," and that "students with exposure to an arts elective in middle school subsequently had significantly higher GPAs and math and reading scores, and decreased odds of school suspension, compared to students not exposed to the arts" (Psychology of Aesthetics, Creativity, and the Arts). According to a report from Fight Crime: Invest in Kids, a nonprofit anti-crime organization comprised of more than 3,000 police chiefs, sheriffs, prosecutors, and other law enforcement leaders, school dropouts are 3.5 times more likely to be arrested than high school graduates and more than eight times as likely to be incarcerated. Further research shows high-school students who earned few or no arts credits were five times more likely not to have graduated than students who earned many arts credits (2008-09 National Longitudinal Survey of Youth of 1997 (NLSY97); U.S. Department of Labor).

The benefits of arts education can be especially profound for children from low-income households, such as those who receive reduced-tuition scholarships to attend Summer Arts Camp or receive worksite and leadership experiences through Arts Aspire. According to researchers at the Harvard University Graduate School of Education, children growing up in economically disadvantaged environments may be at risk for academic difficulties related to vocabulary acquisition because they are exposed to less verbal input. One parent shared how the Center's Summer Arts Camp impacted her daughter: "The ability for effective verbal communication is more important than ever and I know that [my daughter's] abilities in this arena have been significantly enhanced thanks to your summer camp." Through Arts Access education programs that serve Hollywood youth and families, the Center sees first-hand how youth develop the social and leadership skills that divert them and their peer group from harmful activities that can have a negative impact on their lives.

2. Why is this funding needed (What community problem does it address)? What data suggests this program should be implemented with this population or in this geographical location?

The U.S. Dept. of Justice, Office of Juvenile Justice and Delinquency Prevention encourages children to use their creative talents because, "arts and performances help youth develop a sense of identity, independence, discipline, and self-worth. They also help prevent or reduce crime and violence among the young artists and performers involved. According to research, students who participate in band, orchestra, chorus, or drama are significantly less likely than non-participants to drop out of school, be arrested, use drugs, or engage in binge drinking." Arts Aspire meets a need for building so-called "soft" skills that are now widely expected in the 21st Century workforce. Recent reports by The Gates Foundation, the Partnership for 21st Century Skills, and the National Association of Colleges and Employers concluded that these skills include communication, conflict resolution, critical thinking, goal setting, listening, and teamwork. Arts Aspire fosters these qualities through volunteerism, mentorship and hands-on workplace activities that require participants to thoughtfully interact with persons of all ages in a variety of settings, not just with peers and authority figures.

The need for free and reduced-tuition out-of-school arts programming that benefits at-risk children from low-income homes is great in Hollywood, where all but one of the 20 public schools has been designated a Title I school. That includes 12 of 13 elementary schools, 4 of which are in the 33020 zip code, where the Center is located. Each of the 4 middle schools and 3 high schools in Hollywood are Title I. Schools receive Title I designation based on at least 40 percent of enrollment being comprised of youth from low-income families. According to the U.S. Census Bureau's American Community Survey, the median household income in Hollywood from 2015-19 was \$54,251, which is 9% less than the median income in Broward County (\$59,547).

3. Program Summary (3-5 sentences): Provide an overview of program services.

The Art and Culture Center/Hollywood requests funding from the Hollywood Police Dept. LETF to support two Arts Access program initiatives that will serve Hollywood youth in 2021-22: the leadership and worksite development program Arts Aspire, and reduced-tuition scholarships for children from qualifying low-income families who wish to enroll in our 2022 Summer Arts Camp. At a time when the Covid-19 coronavirus has greatly impacted the financial well-being of so many in our community, Arts Access program activities will provide youth of all backgrounds in Hollywood with structured and fully interactive arts-learning experiences outside their K-12 school setting. Information about Arts Aspire and reduced-tuition scholarships will be posted at the Center's website and in the 2022 Summer Arts Camp marketing materials. LETF funding from the Hollywood Police Department would also support staff costs to supervise and mentor approximately 30 Hollywood residents who will participate in more than 2,500 hours of Arts Access activities. Applications for reduced-tuition scholarships are awarded on a first-come, first-serve basis contingent on available funds.

4. Describe the program in detail and how it will be implemented: (Describe Who, What, Where, and When) Please make sure your response includes program successes or challenges if previously funded, Why the agency needs the funding and its impact on the community. Arts Access Leadership and Scholarship programming will be presented in two distinct program periods in FY22: a school-calendar session for Arts Aspire (Oct. 1-May 31) and the nine-week Summer Arts Camp (June 13-Aug. 13, 2022). Arts Aspire will be offered during each session with a focus on the Teen Arts Ambassadors tier designed for high-school students ages 14-18. Arts Ambassadors is the first tier in Arts Aspire development pyramid, which provides additional opportunities for utilizing leadership and workplace skills, with paid stipends, at the Arts Associates (ages 17-18) and Arts Apprentice (18-25) levels.

During the school-calendar session, Teen Ambassadors in Arts Aspire will receive on-the-job training working as volunteers at Center events, as well as participating in activities that build life and technical skills. In many cases, these students have participated previously in the Center's out-of-school visual and performing arts programs, such as Summer Arts Camp, and retain an interest in developing administrative and program delivery skills in the arts. In 2021-22, Teen Ambassadors will attend one mandatory meeting each month. The monthly meetings will focus on the community service side of the program, in which students will pick a nonprofit organization they would like to help. Each Teen Ambassador will research the organization of their choosing and make a presentation to fellow Ambassadors about why that nonprofit deserves their support. Ambassadors will then select one organization for the Arts Aspire group to pursue volunteer opportunities with during the school-calendar session. The monthly sessions will also feature presentations from Center staff, local business leaders, and community members about possible career paths and tips for succeeding in the workforce. Opportunities to volunteer at Center events, such as gallery receptions and our monthly Free Arts! Family Days program, will be available as well. Students assist Center staff in planning, supporting and implementing Free Arts! days offered on the third Sunday of every month. Teen Arts Ambassadors under Arts Aspire earn Community Service hours that are a requirement toward receiving their high-school diploma, as well as benefitting from Bright Futures scholarships to attend college, should they qualify.

LETF funds will also support reduced-tuition scholarships during the Summer Arts Camp being presented June 13 to Aug. 12, 2022. Summer Arts Camp will consist of full- and half-day sessions for ages 4-18 in the visual and performing arts, 2-to-4 weeks in length. Camp sessions will take place at the following venues: Art and Culture Center/Hollywood's Arts School, 1626 Harrison Street; the Center's Community Gallery, 1650 Harrison Street; ArtsPark at Young Circle, 1 Young Circle; and Hollywood Central Performing Arts Center, 1770 Monroe Street. In a typical pre-Covid year, more than 200 youth enroll each summer, with approximately 65% of student enrollments being residents of Hollywood. Camp programs are offered as follows:

- a. Littlest Actors, Littlest Artists: Three two-week program periods (6 sessions total based on separate half-day sessions for Actors and Artists) for ages 4-6. Children may enroll for one or both sessions.
- b. Young Actors, Young Artists: Four two-week program periods (eight sessions total based on half-day sessions for Actors and Artists) for ages 7-12. Children may enroll for one or both sessions.
- c. Broadway Actors: Two 4-week, full-day sessions (ages 8-18), concluding with performances of a Broadway, Jr. musical. Session 1: June 13-July 2; and Session 2: July 11-August 13, 2022.

LETF funds will support up to 12 scholarship awards to Hollywood youth ages 4-18 from low-income households. Qualifying scholarship recipients may enroll in one program session, two or four weeks in length, in the visual and performing arts. All camp sessions meet daily, Monday through Friday, reducing the amount of idle time that can result in wayward choices. Each session concludes with campers presenting an exhibition or performance in the Center's Community Gallery, at ArtsPark at Young Circle, or at the 500-seat Hollywood Central Performing Arts Center. Youth and their caregivers are informed at the outset that the camp mandates attendance levels leading up to their final performing-arts presentation. This instills a sense of personal responsibility and team building that is essential in their personal and academic development. "This camp introduces the attendees to experiences they would not have if they had not attended," wrote one parent in a program survey. "To be able to have fun at camp while building self-esteem, learning important life skills and exercising the brain is priceless! Although the camp is worth every penny, if it were not for the tuition waiver discount, my son could not attend. THANK YOU for the financial assistance!"

Tuition scholarships are available to children from families who qualify for the federal free/reduced school lunch program. Family income must be at or below the following Florida income guidelines set in FY21: \$31,894 for a family of two; \$40,182 (family of three); \$48,470 (family of four). According to Broward County Public Schools, 77% of the K-12 students enrolled in 20 public schools in Hollywood participate in this program each year. Summer Arts Camp is open to all youth, regardless of ability level or socioeconomic status. Applications for reduced-tuition scholarships are available to families who contact the Center's Education Dept. to complete an application, and they are awarded on a first-come, first-serve basis, based on available funds. Since 2009, the Center has awarded more than \$110,000 in tuition funds to 359 youth, the majority from Hollywood.

The primary goal of Summer Arts Camp is to provide youth, including those who have little or no experience in the arts, with a structured and fully interactive arts learning environment. Research shows that children who participate regularly in the arts improve their attention span, learn more quickly, and develop higher level critical thinking skills that lead to positive social outcomes. For each Summer Arts Camp program session, the Center contracts with professional teachers/artists to create curriculum materials. Teachers/artists are assisted by up to 20 high-school and college-age students in Arts Aspire, of which, as many as 15 will be Teen Arts Ambassadors. Arts Aspire students provide 2,500+ volunteer and paid worksite hours over nine weeks. For paid positions in the Arts Associates and Art Apprentice tiers, Center staff designs activities in their departmental area. The Center will recruit candidates through area colleges and universities. Opportunities are also provided to those on a vocational track that is targeted to the arts, such as a sound or lighting tech. The nonprofit arts-and-culture sector is a \$400-million industry that supports 11,000+ full-time equivalent jobs in Broward County (Arts & Economic Prosperity 5 report; Americans for the Arts).

### 5. Describe the Applicant Agency's experience in serving the target population and the capacity of the Applicant Agency to undertake the proposed program.

While other organizations provide arts activities outside the school calendar, the Center's Arts Aspire development program and Summer Arts Camp are the most comprehensive and impactful programs of their kind in the arts for youth in south Broward County and northeast Miami-Dade. The Center is unique in providing financial aid to its high-quality summer camp through reduced-tuition scholarships. Director of Education Amanda Smith oversees Arts Aspire and Summer Arts Camp. She has 19 years of experience in the field of arts and science education. Before joining the Center in 2019, she worked at the Brooklyn Children's Museum, Cleveland Museum of Art, Museum of Contemporary Art Chicago, and Chicago Academy of Sciences / Peggy Notebaert Nature Museum. The target population is families with children ages 4-18 who are at various stages in their development in terms of how they make decisions that result in positive outcomes.

Arts Aspire and Summer Arts Camp instructors encourage good decision-making through activities that require teamwork, creative problem solving, respect for others, accepting responsibility, and following through. Children develop self-confidence and improve their communication skills in a safe, healthy and nurturing environment under the guidance of strong adult role models. This provides the foundation for a safer community by helping children experience success and avoid destructive behaviors that lead to drug use and criminal activity. LETF Funds will support, in part, reduced-tuition scholarships that are available to children from families who qualify for the federal free/reduced school lunch program, thus taking them off the streets and giving them a positive experience during the summer. Approximately 65% of summer camp enrollments live in Hollywood.

Has your agency received funding from LETF? (If yes, identify the source, the \$ amount and provide performance data regarding your contracted outcomes for the various fiscal years your agency was funded).

The Center received a \$10,000 LETF grant for the Arts Access Leadership and Scholarship Program for FY21. To date (Oct. 2020 to March 2021), seven students, including one paid intern, have received 120 hours of worksite and leadership development under the mentorship of Center staff during the school-calendar session. This program was operated despite the challenges of operating during the Covid-19 pandemic, which required a mix of on-site and virtual engagement in program activities. We are closely monitoring vaccination rates for Covid-19 in South Florida with the hope that we can present on our 2021 Summer Arts Camp as proposed.

The Center previously received a \$10,000 LETF grant for the 2019 Summer Arts Camp. This provided direct financial assistance for 15 youth from Hollywood who received tuition aid valued at \$5,280, with additional funds helping underwrite costs for more than 30 instructor positions and supplies for 16 unique performances or exhibitions created by 218 campers. The Center received a \$2,500 grant from Hollywood Police Department's Law Enforcement Trust Fund for reduced-tuition scholarships for Hollywood residents for Summer Arts Camp 2016 and 2017, and \$5,000 in 2015. In 2017, 18 youth from Hollywood received financial aid valued at \$3,937. This represented a portion of the 25 youth who were awarded reduced tuition valued at \$6,250. In 2016, 27 youth from Hollywood received financial aid valued at \$6,775. In 2015, 16 scholarships were awarded to Hollywood residents valued at \$5,785.

### BUDGET NARRATIVE (Required for ALL applications) (Provide an explanation of what the budget will include)

The LETF request supports a portion of the costs to underwrite reduced-tuition scholarships for approximately 12 youth from Hollywood, and for costs associated with Education Staff program positions, outside teachers/artists, and supplies to present Arts Access Leadership and Scholarship activities. Personnel Costs/Salaries represent full-time positions for the Director of Education and two Education Coordinators to design and implement Arts Aspire and daily Summer Arts Camp activities from Oct. 1, 2021 to Aug. 31, 2022; and daily activities for the nine-week summer camp for Technical Director and Theater Director. Additional administrative and programmatic staff positions are for Executive Director to oversee program activities, Design and Web Manager to create print and online marketing materials, Partnerships and Communications Director to coordinate advertising/marketing outreach, Director of Development to write grants and reports for funders, Finance Manager (accounting), and Custodian. The Director of Education supervises Arts Aspire and Summer Arts Camp, and the Education Coordinators (2) implement activities with teachers/artists and students, and communicate with families.

Consultants and Professional Fees (\$34,700) is for contract labor for about 32 outside teacher/artist positions required to deliver program sessions during Summer Arts Camp. Supplies (\$5,500) include art supplies for Arts Aspire and summer camp activities; the rights fees for the scripts to present two theatrical productions; and performance materials for visual pieces and live theatrical productions. Printing and Copying (\$4,000) represents the costs to print Arts Aspire materials, full-color registration brochures that are distributed for Summer Arts Camp; and for event programs for exhibitions and performances that close each camp session. Postage (\$750) is the cost to mail a portion of the summer camp brochures to families on the Center's mailing list, and area community centers. Advertising (\$2,500) includes print and online ads that reach families with school-age children. Insurance (\$990) is for supplemental insurance for camp participants.


