A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, ADOPTING THE DEPARTMENT OF PARKS, RECREATION AND CULTURAL ARTS SYSTEM MASTER PLAN FOR THE PURPOSES OF FUTURE DEVELOPMENT OF THE CITY'S PARKS SYSTEM.

WHEREAS, the Department of Parks, Recreation and Cultural Arts ("PRCA") solicited proposals to conduct a Citywide Parks System Study and create a Citywide Parks Master Plan document; and

WHEREAS, on April 3, 2019, Resolution No. R-2019-076 was approved and authorized an agreement with Barth Associates LLC to develop a comprehensive PRCA Department System Master Plan ("PRSMP"); and

WHEREAS, the purpose of the PRSMP is to help guide the development of parks and recreation facilities, programs, and services for the next five to ten years; and

WHEREAS, findings from the PRSMP will be incorporated into the City's other guiding documents, including the Citywide Comprehensive Plan and Capital Improvements Program; and

WHEREAS, the PRSMP is designed to set forth the City's plans for its park system; and

WHEREAS, the PRSMP is consistent with the policies set forth in Section VI, the Recreation and Open Space Element, of the City's Comprehensive Plan.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it adopts the attached Parks, Recreation and Cultural Arts Department System Master Plan.

Section 3: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
